At the opening of a session, it is essential for Ministers to give notices of motions, so that the Government's business will be placed before the House. Mr. Speaker's inclination would be to begin the forty-five minutes of question time after the notices have been given, and the question of a liberal interpretation of the standing orders to this end is one for his determination, 19.

The paper listing notices of motions and orders of the day is distributed in both proof form and revised form, but still it is not incumbent upon the Government to follow the order of business shown in the document, 433.
