HARRY H. RAWSON, South Wales and its Dependencies, in the Commonwealth of
Governor. Australia.

WHEREAS the Parliament of New South Wales now stands prorogued to Tuesday, the third day of March next: Now, I, Sir HARRY HOLDSWORTH RAWSON, in pursuance of the power and authority in me vested as Governor of the said State, do hereby further prorogue the said Parliament to Tuesday, the tenth day of March now next ensuing, and I do hereby further announce and proclaim that the said Parliament shall assemble for the despatch of business on the aforesaid tenth day of March next, at twelve o'clock at noon, in the buildings known as the Legislative Council Chambers, situate in Macquarie-street, in the city of Sydney: and the Members of the Legislative Council and Legislative Assembly respectively are hereby required to give their attendance at the said time and place accordingly.

Given under my hand and seal, at Sydney, this twenty-sixth day of February, in the year of our Lord one thousand nine hundred and eight, and in the eighth year of his Majesty's reign.

IMPROVEMENT LEASES CANCELLATION (DECLARATORY) ACT (8 ED. VII, No. 4)—

An Act to explain the operation of the Improvement Leases Cancellation Act, 1906; to remove doubt as to the validity of a certain certificate and all acts, things, and proceedings done and held under the said Act; and for other purposes. [Initiated in the Assembly by Mr. Wade, 13 March, 1908. Assented to, 28 April, 1908.]

INDUSTRIAL DISPUTES ACT (8 ED. VII, No. 3)—

An Act to provide for the constitution of boards to determine the conditions of employment in industries; to define the powers, jurisdiction, and procedure of such boards, and to give effect to their awards and appoint a court; to prohibit lock-outs and strikes, and to regulate employment in industries; to preserve certain awards, orders, directions, and industrial agreements; and for purposes consequent thereon or incidental thereto. [Initiated in the Assembly by Mr. Wade, 13 March, 1908. Assented to, 24 April, 1908.]
