WESTERN LANDS (AMENDMENT) BILL:—

Clause 1 having been dealt with,—

Clause 2. The Principal Act is amended—

Amendment
of Act No. 70,
1901.

(a) by inserting next after section 17c the following new section:— New sec. 17cc.

17cc. (1) Notwithstanding anything contained in this Act, the Minister may, by notification published in the Gazette, which notification shall be in or to the effect of the form of Schedule II to this Act, at any time after the twenty-fourth day of August, one thousand nine hundred and forty-three, withdraw from lease the whole or any part of the land which is within the boundaries of any maximum area determined in accordance with section 17c of this Act or within such boundaries as varied pursuant to that section, and which has not been withdrawn under that section. Withdrawals and resumptions.

(2) (a) The Governor, by notification published in the Gazette, may, at any time after the twenty-fourth day of August, one thousand nine hundred and forty-three, resume the whole or any part of any land held in fee simple, or under conditional purchase or conditional lease, where such land, in pursuance of any agreement or arrangement made between the Minister (or the Commissioner on behalf of the Minister) and the holder thereof is to be surrendered to the Crown in part satisfaction of the right of the Minister to withdraw land under the provisions of section 17c of this Act. Resumption of certain freehold, C.P. and C.L. land.

Upon publication of any such notification the land therein described shall vest in His Majesty and shall be deemed to be Crown lands.

Question proposed,—That the clause, as read, stand part of the Bill.

Motion made (Mr. Mair) to insert after the words "Crown lands" on line 35 the words: "Any such Crown lands shall where application is made be disposed of wholly and exclusively to the classes of persons mentioned in paragraphs (a), (b) and (c) of subsection (1) of section 3 of the War Service Land Settlement Act of 1941."

Question proposed,—That the words proposed to be inserted be so inserted.

Point of Order.—Mr. Tully submitted that the amendment was out of order as being outside the Order of Leave.

The Chairman said that the amendment dealt with special cases and special circumstances, he was not satisfied that it was outside the scope of the Bill and he would leave the amendment to the Committee.

Motion made (*Mr. Lawson*),—That the amendment be amended by inserting after the words "Crown lands" the words "made available as original holdings."

Question put,—That the words proposed to be inserted in the proposed amendment be so inserted.

Negatived.

129. (1) The commission or a member thereof and every person authorised in writing by the commission or the registrar or a committee may at any time during working hours enter any building, mine, mine working, ship, vessel, place or premises of any kind wherein or in respect of which any industry is carried on or any work is being or has been done or commenced or any matter or thing is taking or has taken place in relation to which any industrial dispute is pending, or any award has been made, or any offence against this Act is suspected, and may, to the extent and for the purposes named in the authority, inspect and view any work, material, machinery, appliance, articles, book or document therein.

* * * * * [Read.]

Question proposed,—That the clause, as amended, stand part of the Bill.

Motion made (*Mr. Jackson*) to leave out from lines 20-1 the words "of any kind," with a view of inserting the words "other than a private residence."

The Principal Act is further amended by omitting from subsection one of section one hundred and thirty-one the words "shall not be subject to the provisions of this Act other than Parts XIV and XV" and by inserting in lieu thereof the words "shall be subject to the provisions of this Act other than Part VI." Further amendment of Act No. 2, 1940. Sec. 131.

* * * * *

88B. The commission or a committee may on an application or reference to it in that behalf prescribe by award that absolute preference of employment shall be given to the financial members of the industrial union or unions specified in the award.

Absolute preference to unionists.

Question proposed,—That the clause, as read, stand part of the Bill.

Motion made (*Mr. Mair*) to leave out new section 88B with a view of inserting,—

“88B. The commission or a committee shall prescribe by award made or deemed to have been made under this Act that absolute preference of employment shall be given to returned members of the Force.

In this section ‘returned member of the Forces’ means a person who, at the time of his or her appointment or enlistment, was either resident or domiciled in Australia and who was on active service during either the war of 1914-19 or the present war between His Majesty and Germany and her Allies and has had his or her appointment terminated or has received his or her discharge; but does not include any person the termination of whose appointment or whose discharge was due to misconduct or incapacity resulting from his or her own default.”

Point of Order:—That the amendment was outside the order of leave.

The Chairman ruled that the class of persons referred to in the amendment were specifically covered by existing legislation and the latter portion of the amendment was appropriate to section 2 of the Returned Soldiers and Sailors’ Employment Act, that it was outside the scope of the Bill and out of order.

Mr. Treatt moved, That the Chairman leave the Chair to report a Point of Order, and ask leave to sit again, so soon as the Point of Order has been decided by the House. The Point of Order is,—“That the Chairman was wrong when he ruled that an amendment moved by the Leader of the Opposition to clause 9, page 29, lines 15 to 20, which proposed to omit new section 88B and insert a new provision (*as set out above*) was not in order.”

(d) where an advisory board certifies, on the prescribed application, that the average number of adult male employees continuously employed on any separate holding by the owner thereof exceeds three, a further deduction shall, subject to this section, be allowed.

The deduction allowed under this paragraph shall be one thousand pounds in respect of each employee to be taken into account in ascertaining the deduction allowed under this paragraph. The number of employees to be taken into account in ascertaining the deduction allowed under this paragraph shall be ascertained by deducting three from the average number referred to in the certificate of the advisory board.

Provided further that for the purpose of ascertaining such average number, sons and step-sons of the owner employed on any separate holding shall not be taken into account.

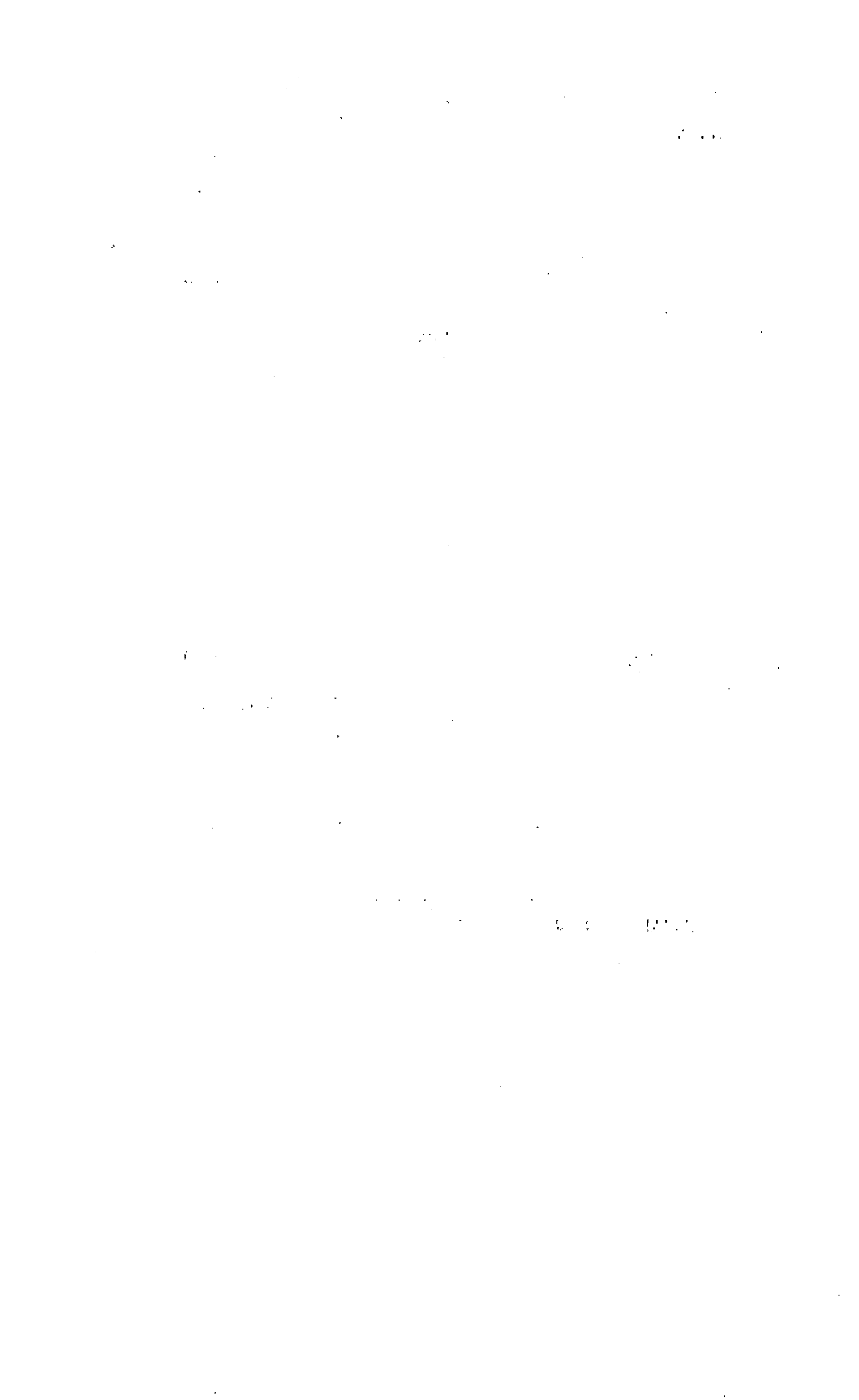
