## **Greyhound Racing Prohibition Bill 2016**

On 23 August 2016 debate resumed on second reading of the *Greyhound Racing Prohibition Bill 2016*. After the Leader of the Opposition, the Premier and 41 other Members had spoken in the debate, which lasted for almost 12 hours, the bill was passed by the Legislative Assembly.

After considering an additional item of business the House adjourned at 3.47 am

The lengthy debate on the bill and the late adjournment of the House were facilitated by a suspension of Standing and Sessional Orders to alter the Routine of Business so as to not call on Private Members' Statements and to permit the House to sit past 10.00 pm.

# Joint sitting to elect a Member of the Legislative Council

On 24 August 2016 Members of the Legislative Assembly attended the Legislative Council Chamber for a joint sitting to elect a person to fill the seat in the Legislative Council vacated as a result of the death of Dr John Kaye.

At the conclusion of the election the Legislative Assembly Members returned to the Legislative Assembly Chamber and a Temporary Speaker reported that Mr Justin Field had been elected to fill the vacancy.

(Procedural note: In the NSW Parliament casual vacancies in the Legislative Council are filled by a person elected at a joint sitting of both Houses called by the Governor. If the casual vacancy was previously filled by a member of a political party, only another member of that party may be elected to fill the vacancy. This is specified by section 22D of the <u>Constitution Act 1902</u>.)
