The Selection of Bills Committee met on Tuesday 23 March to consider whether the following bills be referred to a standing committee for inquiry and report:

- South32 Dendrobium Extension Project Approval Bill 2021
- Civil Liability Amendment (Child Abuse) Bill 2021
- COVID-19 Recovery Bill 2021
- Local Government Amendment Bill 2021
- Mutual Recognition (New South Wales) Amendment Bill 2021
- Real Property Amendment (Certificates of Title) Bill 2021
- Independent Commission Against Corruption Amendment (Publication of Ministerial Register of Interests) Bill 2021.

The committee makes the following recommendations:

- (1) That:
  - (a) the provisions of the Mutual Recognition (New South Wales) Amendment Bill 2021 be referred to Portfolio Committee No. 1 – Premier and Finance for inquiry and report,
  - (b) the bill be referred to the committee upon receipt of the message on the bill from the Legislative Assembly,
  - (c) the committee report by 11 May 2021, and
  - (d) on the report being tabled, a motion may be moved immediately for the first reading and printing of the bill.
  
- (2) That the following bills not be referred to a standing committee for inquiry and report, this day.
  - (a) South32 Dendrobium Extension Project Approval Bill 2021,
  - (b) Civil Liability Amendment (Child Abuse) Bill 2021,
  - (c) COVID-19 Recovery Bill 2021,
  - (d) Local Government Amendment Bill 2021,
  - (e) Real Property Amendment (Certificates of Title) Bill 2021, and
  - (f) Independent Commission Against Corruption Amendment (Publication of Ministerial Register of Interests) Bill 2021.
