Report of a study tour to Europe by a delegation of the STAYSAFE Committee, October 2000

This report of the STAYSAFE Committee documents the activities undertaken by a delegation of the Committee who participated in a visit of inspection to Europe in October 2000 to investigate road safety issues.

A delegation of the STAYSAFE Committee conducted a visit of inspection to Europe over the period Sunday 15 October 2000 to Saturday 28 October 2000 to investigate road safety issues, including: attendance at a conference on strategic planning for road safety in the United Kingdom at London; attendance at a conference on road safety in Hungary at Budapest; and investigations of issues in school travel; pedestrian safety, bicycle safety; and social, cultural and ethnicity issues in road safety.

The delegation comprised the Hon. John Tingle MLC and Mr David Campbell MP. Ms Reba Meagher MP, Parliamentary Secretary for Roads, accompanied the delegation. Mr Ian Faulks, of the STAYSAFE Committee secretariat, also accompanied the delegation.

The Hon. John Tingle MLC and Mr David Campbell MP reported to the STAYSAFE Committee at its meeting of Wednesday 11 April 2001.

During the visit of inspection, meetings were held in England and Hungary.

ENGLAND

In England, the delegation attended a conference on strategic planning for road safety in the United Kingdom, held in London, 17 October 2000, and organised by the Parliamentary Advisory Council for Transport Safety. Significant papers presented at the conference examined issues such as: the new United Kingdom road safety strategy; European Union perspectives on road safety and transport safety; and community level interventions to improve road safety.

While in England, the delegation held meetings and conducted inspections in London, Bristol, and Leeds.

In London, the delegation received briefings and discussions in meetings with the following persons:
