#### SELECTION OF BILLS COMMITTEE

The Selection of Bills Committee met on Tuesday 12 November 2019 at 1.16 pm to consider whether the following bills should be referred to a standing committee for inquiry and report:

- Digital Restart Fund Bill 2019
- State Revenue Legislation Further Amendment Bill 2019
- Design and Building Practitioners Bill 2019
- Environmental Planning and Assessment Amendment (Territorial Limits) Bill 2019
- Professional Engineers Registration Bill 2019
- Better Regulation Legislation Amendment Bill 2019
- Justice Legislation Amendment Bill (No 2) 2019
- Liquor Amendment (Harm Reduction Areas) Bill 2019
- Liquor Amendment (Intoxication) Bill 2019
- Child Protection (Nicole's Law) Bill 2019
- Central Coast Drinking Water Catchments Protection Bill 2019
- Real Estate Services Council Bill 2019.

The committee makes the following recommendations:

- 1. That:
  - (a) the provisions of the Digital Restart Fund Bill 2019 be referred to the Portfolio Committee No. 6 Transport and Customer Service for inquiry and report,
  - (b) the bill be referred to the committee upon receipt of the message on the bill from the Legislative Assembly,
  - (c) that the committee report by Tuesday 17 March 2020, and
  - (d) on the report being tabled, a motion may be moved immediately for the first reading and printing of the bill and that the bill proceed through all remaining stages according to standing and sessional orders.
- 2. That:
  - (a) the provisions of the Environmental Planning and Assessment Amendment (Territorial Limits) Bill 2019 be referred to the Portfolio Committee No. 7 – Planning and Environment for inquiry and report,
  - (b) the bill be referred to the committee upon receipt of the message on the bill from the Legislative Assembly,
  - (c) that the committee report by Tuesday 17 March 2020, and
  - (d) on the report being tabled, a motion may be moved immediately for the first reading and printing of the bill and that the bill proceed through all remaining stages according to standing and sessional orders.

- 3. That the following bills not be referred to a standing committee for inquiry and report, this day:
  - (a) State Revenue Legislation Further Amendment Bill 2019
  - (b) Design and Building Practitioners Bill 2019
  - (c) Professional Engineers Registration Bill 2019
  - (d) Better Regulation Legislation Amendment Bill 2019
  - (e) Justice Legislation Amendment Bill (No 2) 2019
  - (f) Liquor Amendment (Harm Reduction Areas) Bill 2019 and cognate Liquor Amendment (Intoxication) Bill 2019

  - (h) Central Coast Drinking Water Catchments Protection Bill 2019
  - (i) Real Estate Services Council Bill 2019.
