Proposal to refer a bill to a committee

Name of bill: Warnervale Airport (Restrictions) Repeal Bill 2020

Reasons for referral/principal issues for consideration:

- 1. The original Act was to ensure independent scrutiny over any plans to increase the operation at the airport which currently has approx. 65 000 people living within the 7.5km radius covered by the Act. (predicted to be 80 - 90 000 by 2036.)
 - Ensure that adequate public consultation and scrutiny is available if the Act is repealed given that Central Coast Council is both the Owner and Operator of the facility.
 - b. Whether aircraft larger than 5700kg can use the landing strip without adequate noise studies being done if the Act is repealed.

Name of bill: Local Land Services Amendment (Land Management and Forestry) Bill 2020

Reasons for referral/principal issues for consideration:

There are polarised views on the matter between the farming and timber industries and associated unions, and environmentalists. It would be useful given the concerns raised by industries which are key drivers of jobs in rural and regional NSW, that they are given the opportunity to address how the SEPP is impacting them, particularly given their concerns about the Government's consultation process.
