- NSW Jobs First Bill 2020
- Drug Supply Prohibition Order Pilot Scheme Bill 2020

Drug Supply Prohibition Order Pilot Scheme Bill 2020

Reasons for referral/principal issues for consideration:

those already convicted of a drug offence under the Drugs Misuse and Trafficking Act 1985. It allows assist police to gather evidence of drug supply and drug manufacture' by undertaking surveillance on the Coffs-Clarence, Hunter Valley and Orana Mid-Western districts. The objective of the scheme is to The bill establishes a 2-year pilot scheme to be implemented into the Bankstown Police Command, and within the last 10 years. They can be searched, along with their premises and vehicles, at any time police to stop, detain and search anyone over the age of 18 who has been charged with a drug offence without a warrant.
