The Selection of Bills Committee met on Tuesday 19 October to consider whether the following bills be referred to a standing committee for inquiry and report:

- Coastal Management Amendment Bill 2021
- Energy Legislation Amendment Bill 2021
- Local Government Amendment (COVID-19-Elections Special Provisions) Bill 2021
- Water Industry Competition Amendment Bill 2021
- Companion Animals Amendment (Puppy Farms) Bill 2021
- Constitution Amendment (Virtual Attendance) Bill 2021
- Crimes Amendment (Display of Nazi Symbols) Bill 2021
- ICAC and Other Independent Commissions Legislation Amendment (Independent Funding) Bill 2021
- Modern Slavery Amendment Bill 2021
- Public Interest Disclosures Bill 2021
- Voluntary Assisted Dying Bill 2021

The committee makes the following recommendations:

(1) That:

- (a) the Companion Animals Amendment (Puppy Farms) Bill 2021 be referred to Portfolio Committee No. 7 - Planning and Environment for inquiry and report,
- (b) the bill be referred to the committee at the conclusion of the mover's second reading speech,
- (c) the resumption of the second reading debate on the bill not proceed until the tabling of the committee report,
- (d) the committee report by 23 November 2021.
- (2) That:
 - (a) the Public Interest Disclosures Bill 2021 be referred to Portfolio Committee No. 1 Premier and Finance for inquiry and report,
 - (b) the bill be referred to the committee at the conclusion of the mover's second reading speech,
 - (c) the resumption of the second reading debate on the bill not proceed until the tabling of the committee report,
 - (d) the committee report by 15 November 2021.
- (3) That:
 - (a) the provisions of the Voluntary Assisted Dying Bill 2021 be referred to the Standing Committee on Law and Justice for inquiry and report,

- (b) the bill be referred to the committee upon receipt of the message on the bill from the Legislative Assembly,
- (c) the committee report by the first sitting day in 2022, and
- (d) on the report being tabled, a motion may be moved immediately for the first reading and printing of the bill.
- (4) That the following bills not be referred to a standing committee for inquiry and report, this day.
 - (a) Coastal Management Amendment Bill 2021,
 - (b) Energy Legislation Amendment Bill 2021,
 - (c) Local Government Amendment (COVID-19-Elections Special Provisions) Bill 2021,
 - (d) Water Industry Competition Amendment Bill 2021,
 - (e) Constitution Amendment (Virtual Attendance) Bill 2021,
 - (f) Crimes Amendment (Display of Nazi Symbols) Bill 2021,
 - (g) ICAC and Other Independent Commissions Legislation Amendment (Independent Funding) Bill 2021, and
 - (h) Modern Slavery Amendment Bill 2021.
