The Selection of Bills Committee met on Tuesday 19 March 2024 to consider whether the following bills be referred to a standing committee for inquiry and report:

- Bail and Crimes Amendment Bill 2024 (not yet accompanied by a Statement of Public Interest),
- Children and Young Persons (Care and Protection) Amendment Bill 2024 (not yet accompanied by a Statement of Public Interest),
- Conversion Practices Ban Bill 2024 (not yet accompanied by a Statement of Public Interest),
- Emergency Services Levy Amendment Bill 2024 2024 (accompanied by a Statement of Public Interest),
- Electoral Amendment (Voter ID and Electronic Mark Off) Bill 2024,
- Environment Protection Legislation Amendment (Stronger Regulation and Penalties) Bill 2024 (not yet accompanied by a Statement of Public Interest),
- Independent Commission Against Corruption Amendment (Ministerial Diary Disclosure) Bill 2024, and
- Rural Fires Amendment (Red Fleet) Bill 2024.

The committee makes the following recommendations:

- (1) That:
  - (a) the provisions of the Conversion Practices Ban Bill 2024 be referred to the Law and Justice Committee for inquiry and report,
  - (b) the bill stand referred to the committee on receipt of the message from the Legislative Assembly forwarding the bill, the bill being read a first time and the Statement of Public Interest being tabled, and
  - (c) the committee report by 14 May 2024.
- (2) That the following bills not be referred to a standing committee for inquiry and report this day:
  - (a) Bail and Crimes Amendment Bill 2024,
  - (b) Children and Young Persons (Care and Protection) Amendment Bill 2024,
  - (c) Emergency Services Levy Amendment Bill 2024

- (d) Electoral Amendment (Voter ID and Electronic Mark Off) Bill 2024,
- (e) Environment Protection Legislation Amendment (Stronger Regulation and Penalties) Bill 2024,
- (f) Independent Commission Against Corruption Amendment (Ministerial Diary Disclosure) Bill 2024, and
- (g) Rural Fires Amendment (Red Fleet) Bill 2024.
