# HEARING DATE: 5 MARCH 2024 SUPPLEMENTARY QUESTIONS

### **Question 1**

How much economic expenditure is estimated to be generated from the NRL 2024 Grand Final in Sydney?

#### **Answer**

I am advised:

Destination NSW estimates that the 2024 NRL Premiership Men's and Women's Grand Final will generate \$25.6 million in visitor expenditure.

#### Question 2

Was it the NRL or the NSW Government that made the first approach regarding the 2024 NRL Grand Final?

# Answer

I am advised:

The NSW Government and NRL have been engaged in discussions about the NRL Grand Final. As a result of these discussions, on 4 March 2024, the NSW Government announced that the Government and the Australian Rugby League Commission had reached an agreement to host the 2024 NRL and NRLW Grand Finals in Sydney.

# **Question 3**

How much economic expenditure is estimated to be generated from the A-Leagues Unite Round over the term of the arrangement?

#### Answer

I am advised:

Destination NSW estimates that the Unite Round will deliver \$10.2 million in visitor expenditure over the 2023-24 and 2024-25 seasons.

# **Question 4**

Was it the A-Leagues or the NSW Government that made the first approach regarding the 2024 NRL Grand Final?

The A-Leagues and NSW Government have not discussed the 2024 NRL Grand Final. The A-Leagues 'Unite Round' is a new concept which sees a full round of A-Leagues men's and women's fixtures played within NSW across one weekend. This proposal was put forward to the NSW Government by the Australian Professional Leagues (APL).

How much economic expenditure is generated from the A-Leagues Unite Round over the term of the arrangement?

# **Question 10**

Given the cessation of funding programs such as the Regional Events Acceleration Fund, has Destination NSW budgeted for the increase in need to fund regional events?

# Answer

I am advised:

The Regional Event Acceleration Fund was administered by the Department of Regional NSW, not Destination NSW.

Destination NSW's budgeted expenditure in 2023-24 is \$339.1 million, the second-highest Destination NSW budget on record. This budget ensures Destination NSW is well resourced to secure and retain events for the NSW events calendar.

As an example, on 12 March 2024, the NSW Government announced that the Regional Event Fund had opened to applications for regional events held in the 2024-25 financial year.

Destination NSW will manage the \$1.5 million Regional Event Fund and provide support to regional events through three streams:

- Incubator Event stream: New events in their first or second years can receive up to \$20,000 of seed funding to support activities that are likely to establish an event as a driver of visitation.
- Flagship Event stream: Emerging events running for over two years can receive grants of \$20,000 to increase their profile and encourage visitation. Events that have already received the maximum of three annual grants will be eligible for grants of \$30,000 over three years.
- Event Development stream: Established and proven events that have previously received and completed triennial funding through the Flagship Event stream can receive grants of up to \$50,000 to support growth initiatives in the event's strategic plan.

Applications to the Regional Event Fund will close on Tuesday 9 April 2024.

# **Question 11**

Will major regional sporting fixtures be funded by Destination NSW?

#### **Answer**

I am advised:

Destination NSW's budgeted expenditure in 2023-24 is \$339.1 million, the second-highest Destination NSW budget on record. This budget ensures Destination NSW is well resourced to secure and retain events for regional NSW.

# **Question 12**

What role did you play in the drafting of the Independent Commission Against Corruption Amendment (Validation) Act 2015?

# **Answer**

I am advised:

The former Department of Premier and Cabinet assisted the NSW Government in the preparation of the *Independent Commission Against Corruption Amendment (Validation) Bill 2015* for the consideration of the NSW Parliament.

### **Question 13**

On 19 July 2021 in the case between R v Macdonald; R v Edward Obeid; R v Moses Obeid (No 17) [2021] NSWSC 858, Justice Fullerton of the NSW Supreme Court found that Mr Eddie Obeid, Mr Ian MacDonald, along with Mr Moses Obeid, were guilty of participation in a conspiracy.

In those court proceedings, the Crown Prosecutor, Ms Sophie Callan SC, categorically stated several times that that the Crown did not make any adverse imputations against Cascade, its directors or shareholders in any respect.

Justice Fullerton confirmed this fact in her judgement stating (at paragraph 2026): "The Crown also submitted that the Cascade Coal P/L witnesses were, from their [the Crown's] perspective, involved in "a series of legitimate arm's length commercial transactions" and, for that reason, "their understanding and involvement is not material to determination of the offence charged".

Are you aware of the statement of both Ms Callan SC, and Justice Fullerton?

#### **Answer**

I am advised:

Paragraph 2026 of the judgment of Justice Fullerton in *R v Macdonald; R v Edward Obeid; R v Moses Obeid (No 17)* [2021] NSWSC 858 provides as follows:

The Crown submitted that the Court would not regard it as appropriate to give a *Jones v Dunkel* direction because the Crown's failure to call those witnesses does not give rise to a reasonable doubt about the guilt of the accused. In respect of those witnesses it identified as "close associates" of the Obeids, the Crown submitted that the nature of their involvement in relevant events would render their evidence unreliable. The Crown also submitted that the Cascade Coal P/L witnesses were, from their perspective, involved in "a series of legitimate arm's length commercial transactions" and, for that reason, "their understanding and involvement is not material to determination of the offence charged". [Citation omitted]

### Question 14

In an email dated 26 March 2020, Ms Catherine Ellis, Principal Lawyer Independent Commission against Corruption advised the solicitor for Mr John Atkinson that: "On 24 March 2020, the Commission received advice from the DPP that there is insufficient evidence to commence criminal proceedings against your client. The Chief Commissioner, the Hon Peter Hall QC, has accepted advice". Are you aware of that email?

#### **Answer**

#### I am advised:

The Cabinet Office is aware of a submission by Mr John Atkinson to the inquiry of the Committee on the Independent Commission Against Corruption entitled *Reputational impact on an individual being adversely named in the ICAC's investigations*. # **Question 15**

Taking into account the submission of Ms Callan SC, the judgement of Justice Fullerton, along with the 26 March 2020 email from Ms Ellis of the ICAC, do you still stand by your assertion in evidence given to the committee where you said, inter alia, "In substance they had committed what was widely understood at the time to constitute corrupt conduct..."?

# **Answer**

#### I am advised:

The Cabinet Office has no amendments or clarifications to make regarding the evidence provided to the Committee in this matter.

The NSW Independent Commission Against Corruption (ICAC) made corrupt conduct findings in respect of five Cascade Coal Pty Ltd investors in its July 2013 report Investigation into the conduct into Ian Macdonald, Edward Obeid Snr, Moses Obeid and others following an investigation known by the moniker 'Operation Jasper'.

On 29 July 2014 in Duncan v ICAC; McGuigan v ICAC; Kinghorn v ICAC; Cascade Coal v ICAC [2014] NSWSC 1018, the Supreme Court quashed the findings against one of the investors, and dismissed the judicial review application in respect of the remaining four investors. The four investors subject to corrupt conduct findings later unsuccessfully appealed the Supreme Court decision - see *Duncan v Independent Commission Against Corruption* [2016] NSWCA 143.

### **Question 16**

In your evidence that you gave to the Committee (page 23 of the transcript) you said, inter alia, "I think the individuals in this matter had exercised all of their legal rights of appeal". Are you aware that the ICAC, the Crown Solicitors Office, and the NSW Court of Appeal had agreed and determined to set aside findings of corruption asserted by the ICAC against Messrs Duncan, McGuigan, Poole, and Atkinson, as those assertions were beyond the power of the ICAC?

#### **Answer**

# I am advised:

The Cabinet Office is aware that, in the context of an appeal by Messrs Duncan, McGuigan, Poole and Atkinson from *Duncan v ICAC; McGuigan v ICAC; Kinghorn v ICAC; Cascade Coal v ICAC* [2014] NSWSC 1018, the Crown Solicitor's Office wrote to those individuals on 23 April 2015, on behalf of the Independent Commission Against Corruption (ICAC).

In that letter, the Crown Solicitor's Office indicated, on the basis of the law after the decision of the High Court of Australia in *Independent Commission Against Corruption v Cunneen* [2015] HCA 14, the ICAC would consent to orders to the effect that its findings of corrupt conduct against those individuals in its Operation Jasper Report were beyond power.

Correspondence from the NSW Court of Appeal to the parties on 6 May 2015 noted the proposed consent orders and that, at the next hearing in the matter, the Court was minded to make a declaration that the ICAC had no jurisdiction to determine that those individuals had engaged in corrupt conduct within the meaning of the ICAC Act.

Those orders and the declaration were never made by the Court of Appeal.

The Court of Appeal's judgment in that matter is at *Duncan v Independent Commission Against Corruption* [2016] NSWCA 143.

# **Question 17**

The agreement to set aside the findings was listed for hearing at 9.15am on Friday 8 May 2015. Are you aware that the passing of the "Validation Act" on the 6th of May 2015 some two days prior extinguished any opportunity to pursue their legal rights as agreed between the parties?

# **Answer**

I am advised:

The Cabinet Office is aware of the effect of the *Independent Commission Against Corruption Amendment (Validation) Act 2015* on the proceedings in *Duncan v Independent Commission Against Corruption* [2016] NSWCA 143.

# **Question 18**

In relation to the reporting of road fatalities:

- (a) Does NSW use reporting and terminology similar to other Australian jurisdictions?
- (b) Has reporting and terminology been discussed, either bilaterally or multilaterally with other Australian jurisdictions?

(18)(a) Transport for NSW follows terminology specified in the National Guideline for Reporting and Classifying Road Vehicle accidents.

(b) Reporting and terminology have been discussed with other Australian jurisdictions on an ad hoc basis in the past for specific cases.

(21) and (22) Legislation relating to road vehicle safety includes both Commonwealth and State instruments. Commonwealth legislation regulates the first supply of motor vehicles to market and provides the head of power for making the vehicle standards called the Australian Design Rules (ADRs). This legislation is referenced across various NSW Acts. NSW has also adopted the Heavy Vehicle National Law, which regulates aspects of the use of heavy vehicles.

Key relevant NSW legislation within the remit of the Minister for Roads (jointly administered with the Minister for Regional Transport and Roads and the Minister for Transport) is the Road Transport Act 2013 No 18.

Regulations relating to road vehicle safety also include:

The NSW Government is not progressing with changes to clearways on The Grand Parade between Kyeemagh and Sans Souci, per its election commitment.

Transport for NSW consulted with the community on the Access and Place Improvements for The Grand Parade Kyeemagh to Sans Souci project from 23 September to 17 October 2022. A community consultation report was published on 3 February 2023. A summary is provided in the Engagement Report which is available on the Transport for NSW website: https://www.transport.nsw.gov.au/projects/current-projects/grand-parade.

Transport for NSW is looking at other options to alleviate traffic congestion while maintaining access to businesses and local amenities.

### **Question 32**

Can the Minister please provide an update on the review of the application of speed zones at work sites?

# **Answer**

# I am advised:

The safety of workers along the road corridor is the number one priority for Government.

The NSW Government has committed to removing construction speed limits outside construction hours where it is safe to do so. Examples of projects where speed limits have been restored outside of the times workers are on the road are the Heathcote Road upgrade (The Infantry Parade to the Avenue) and King Georges Road Widening Stage 1.

Transport for NSW and SafeWork NSW has committed to review their protocols to consider increasing speed limits when workers are not present at road work zones Transport for NSW does not manage temporary traffic management practices, including speed limits, at work sites of utility providers and local government. However, the Traffic Control at Work Sites Technical Manual' (and Quality Assurance (QA) specification G10 'Traffic Management' are available for use by all road operators, including local councils.

### **Question 33**

In relation to the NSW Government's demerit point reduction trial, when will eligible drivers start seeing one demerit point removed?

### **Answer**

Eligible customers will start to have demerit points removed from mid-April 2024.

# **Question 34**

Can the Minister provide an update on the development of a new online Towards Zero Collaboration Hub?

# **Answer**

### l am advised:

Stage One of the Towards Zero Collaboration Hub was delivered in September 2022, which was a consolidation of road safety information and resources to support local road safety planning and communications. This stage received strong positive feedback from across Local Government and community organisations.

The second and final stage of the Towards Zero Collaboration Hub was recently launched in March 2024 and now includes a log-in only section where users can collaborate and build partnerships through discussion forums, webinars and workshops.

## Question 35

Can the Minister provide an update on the implementation of a Towards Zero Ambassador Program?

# **Answer**

The establishment of a Towards Zero Ambassador Program is an action of the 2026 Road Safety Action Plan.

The Program will encourage local leaders in local councils to be road safety champions, showcase local road safety partnerships and initiatives, and promote the achievement of Towards Zero targets within their local communities.

# **Question 36**

Can the Minister provide an update on the review and expansion of the Local Government Road Safety Program?

#### **Answer**

I am advised:

Transport for NSW has issued a request for quotations inviting independent organisations to conduct a review of the Local Government Road Safety Program. Key stakeholders will

be consulted as part of the review. The review is scheduled to be completed by the end of 2024.

### **Question 37**

In relation to Road Safety Officers, can the Minister provide an update on the following:

- (a) What portion of Councils in NSW have access to a Road Safety Officer?
- (b) How many Councils do Road Safety Officers service on average?
- (c) Are Road Safety Officers employed directly by Councils?
- i. If not, what are their employment arrangements?
- (d) What are the NSW Government's targets in relation to expanding access to Road Safety Officers by Councils?
- (e) What procedures are in place to measure the success of Road Safety Officers in facilitating better road safety planning and integration?

### Answer

### I am advised:

- (a) and (b) All councils can participate in the program. As at January 2024, of the 128 Local Government Areas in NSW, 84 participate in the program, employing 75 Road Safety Officers, noting some councils share one officer.
- (c) Yes.
- (d) and (e) All participating councils in the Local Government Road Safety Program are required to complete Local Road Safety Action Plans. Transport for NSW reviews the Local Road Safety Action Plans.

The Action Plans are also used to approve project funding requests, with Transport for NSW reviewing the Action Plan and nominated projects to ensure they are appropriate and consistent with program guidelines.

# Question 38

Can the Minister provide an update on the development of a new online NSW Road Safety Education Centre?

#### **Answer**

# l am advised:

An education framework to guide the development of effective and innovative road safety learning resources and experiences has been developed. The digital build is expected to commence shortly with an expected public launch in 2025. Meanwhile, existing online road safety education resources continue to be maintained.

# **Question 39**

Can the Minister provide an update on the development of a vehicle renewal program that provides former fleet vehicles from Government and corporate partners to younger and disadvantaged drivers to increase their use of safer vehicles?

# **Answer**

# I am advised:

In May 2022, Transport for NSW entered into a Memorandum of Understanding with Empowr Mobility and Essential Energy to deliver a pilot program that gave access to five-star safety rated ex-fleet vehicles to young and disadvantaged drivers.

The pilot was comparatively small scale, with seven individual and two organisations participating. It finished on 28 February 2023.

What is the Minister's plan to strengthen the NSW Government Fleet Policy to extend safety requirements to Government contractors?

#### **Answer**

The standard is scheduled to be published at the end of June 2024 for public comment.

Can the Minister provide an update on the development of a new heavy vehicle safety strategy?

# **Question 44**

How many Seatbelt Detection Cameras have been installed to date?

The automated enforcement of seatbelt offences will commence on 1 July 2024. Mobile Phone Detection Cameras, which are existing camera systems used to enforce illegal mobile phone use, will be used to enforce seatbelt offences, including non-use and incorrect wearing of seatbelts.

# **Question 45**

How many Seatbelt Detection Cameras are currently in operation?

When the automated enforcement of seatbelt offences commences on 1 July 2024, all 47 Mobile Phone Detection Cameras will enforce both illegal mobile phone use and seatbelt non-compliance.

# **Question 46**

Can the Minister provide an update in relation to the status of reforms to post-crash drug and alcohol testing?

#### **Answer**

### I am advised:

Transport for NSW is investigating options for legislative changes with key agency partners to provide a more comprehensive testing framework for drivers involved in crashes resulting in grievous bodily harm.

### Question 47

What is the current status in relation to the 2026 Road Safety Action Plan target to halve deaths and reduce serious injuries by 30% on NSW roads by 2030?

# **Answer**

# I am advised:

Road safety is a high priority, with a total of \$2.6 billion in funding allocated over the next four years for road safety. This significant investment continues the NSW Government's commitment to the NSW 2026 Road Safety Action Plan, with the goal of making the roads safer for everyone by reducing deaths and serious injuries.

On 22 February 2024, the NSW Government hosted the NSW Road Safety Forum to lead the conversation on outcomes to address the return to pre-Covid levels of road fatalities.

#### **Question 48**

Can the Minister please provide an update on the NSW Government's policy to mandate toll operators to issue consolidated toll notices to any road users commencing in 2023-24, including:

- (a) When this policy will be implemented?
- (b) What is the cost of this policy?

The Interim Tolling Report has recently been released and considers a wide range of potential changes and improvements for motorists. As part of the NSW Government response to the Final Tolling Report, more information will be available on any changes to the Toll Notice.

# Question 49

Will a pedestrian safety barrier be installed on Forest Way Belrose near Glen Street? (a) If yes, when will it be installed?

Transport for NSW is currently seeking funding through the current round of State and Federal Road Safety programs for the installation of pedestrian fencing along Forest Way in proximity of Glen Street and Wearden Road.

# **Question 50**

This timeframe will allow councils to prepare detailed plans and maintenance works that can be phased over multiple financial years without the uncertainty of further funding, resulting in effective and efficient resource planning.

Councils are also eligible for funding from the Australian Government through various Federal funded transport programs and grants.

# **Natural Disaster Arrangements for local councils**

To assist councils meet the Disaster Recovery Funding Arrangement requirements, the 'NSW Natural Disaster Essential Public Asset Restoration Guidelines' have been developed.

The Guidelines describe the NSW Government's arrangements for providing assistance to local councils for the restoration of essential public assets that have been damaged as a direct result of eligible disasters.

Resource documentation such as application forms and contact details for councils in the event of a natural disaster are available on the Transport for NSW website.

# JENNY KEE AND LINDA JACKSON: STEP INTO PARADISE

Public Program December 2019 – March 2020. Creative resident Rosie Deacon delivered a series of intergenerational workshops as part of the Step into Paradise summer program, exploring themes of identity and expression through spectacle and adornment.

### **Question 349**

What are the terms of these residencies?

### Answer

The 2024 residency program will be based on the outcome of a formal EOI process. There is no pre-determined set number of residencies, it depends on the applications received and the merit-based assessment by the selection panel, which will include representatives from the Powerhouse, UTS and an external industry leader.

The 2024 residency program offers terms between one and three years. All creative residents receive subsidised rent at approximately 50% of the commercial value, taking into account location, amenity, size and condition.

Previous EOIs were held in 2019, 2020, 2021 and 2022. All residents were provided a lease term up to the expected closure of the site at the time of applying. This has changed with NSW Government policy. With clarity of the project, and to ensure equitable access, all current residents will reapply in 2023 alongside an external EOI.

The Powerhouse Creative Industries Residency Program does not provide any funding or grants to participants.
