All other speakers:	10 mins
Debate interrupted after 90 mins for the mover in reply:

Suspension of standing orders (SO 204)

Debate:	30 mins
Speakers:	5 mins

SSO for SO 52 or SO 55

Mover/Minister only:	5 mins

Questions

Question time (SO 64, as amended by sessional order)*

Question:	1 min
Answer:	2 mins
Discussion:	1 min

Note: A Minister may seek leave to extend the time for an answer by 1 min.

*The clock must be stopped when a point of order is taken.

Minister/Opposition:	10 mins
2 Crossbench members from different parties:	5 mins

Government bills (SO 144)

<u>Second and third readings</u>	
Mover/Lead Opposition/ first crossbench speaker:	40 mins
All other speakers:	20 mins
Mover in reply:	20 mins

Note: A member may move to extend their time for debate by not more than 10 mins. Question is put without debate.

<u>Committee of the Whole</u>	
Speakers:	15 mins

Note: A speaker may seek leave to continue speaking in Committee for a period of no longer than 15 mins.

Private members' bills (SO 193)

<u>Leave to bring in bill</u>	
Debate:	60 mins
Speakers:	10 mins

Debate interrupted 10 mins before end of debate (ie. after 50 mins) for the mover in reply:
