NSW Parliament Strategic Plan 2019-2023

Introduction

The Parliament of New South Wales comprises the Sovereign and two autonomous and distinct Houses: the Legislative Council and the Legislative Assembly. By section 5 of the Constitution Act 1902, the Parliament has power to make laws for the peace, welfare, and good government of New South Wales in all cases whatsoever, subject to the provisions of the Commonwealth of Australia Constitution Act. Under the Westminster system, as adopted in New South Wales, the executive government is formed out of the members of the Parliament and is subject to the scrutiny and control of the Parliament according to a system of responsible government. Parliament performs these functions on behalf of the people of New South Wales.

The two Houses of the Parliament are supported by three operational departments: the Department of the Legislative Council, the Department of the Legislative Assembly and the Department of Parliamentary Services. The Departments of the Legislative Council and Legislative Assembly (the House Departments) provide procedural, analytical and administrative support to the respective Houses and their committees. The Department of Parliamentary Services provides a broad range of corporate and administrative support services to members, their staff and to the House Departments, as well as maintaining the 98 electorate offices across the state.

The departments have a common purpose: to provide the necessary services and support to the Houses to ensure that they can fulfil their constitutional roles as legislative and representative bodies while holding the executive government to account.

This Strategic Plan 2019-2023 provides an overview of the purpose of the NSW Parliament, the building blocks that create the preconditions for an effective Parliament, and the five priority areas that the parliament's administration will collectively focus on in the 57th Parliament of NSW.

The Plan is underpinned by strategic plans for each of the departments, a Masterplan that outlines the 10 year forward capital investment plan for the Parliament and a variety of operational and strategic planning documents focused on particular aspects of the Parliament's functions.

We preserve the corporate memory and ensure continuity of the institution while innovating our services and service delivery.
