INTRODUCTION

The Parliament of New South Wales comprises the Crown, represented by the Governor of NSW and two separate and sovereign Houses: the Legislative Council and the Legislative Assembly.

By section 5 of the Constitution Act 1902, the Parliament has power to make laws for the peace, welfare and good government of New South Wales in all cases whatsoever, subject to the provisions of the Commonwealth of Australia Constitution Act. Under the Westminster system, as adopted in New South Wales, the executive government is formed out of the members of the Parliament and is subject to the scrutiny and control of the Parliament according to a system of responsible government. Parliament performs these functions on behalf of the people of New South Wales.

The two Houses of the Parliament are supported by three operational departments: the Department of the Legislative Council, the Department of the Legislative Assembly and the Department of Parliamentary Services. The Departments of the Legislative Council and Legislative Assembly (the House Departments) support their respective Houses and committees. The Department of Parliamentary Services provides a broad range of corporate and administrative support services to members, their staff and to the House Departments, as well as maintaining the 98 electorate offices across the State.

The departments have a common purpose: to provide the necessary services and support to the Houses to ensure that they can fulfil their constitutional roles as legislative and representative bodies while holding the executive government to account.

CONTEXT FOR THE 58TH PARLIAMENT

The March 2023 election resulted in the establishment of a minority Government in the Legislative Assembly and a finely balanced Legislative Council, increasing the complexity of parliamentary proceedings and processes for the 58th Parliament.

The demographic make-up of the membership of the two Houses is now more reflective of the NSW community than ever before. The Parliament is committed to building on this progress as part of its role representing the entire NSW community, with a focus on regional outreach and engaging with diverse communities.

The 2022 report of a landmark review into safe, inclusive and respectful workplace behaviour has brought a new focus on behavioural standards. Parliamentary leaders and Members are committed to creating a more respectful institution and enhancing public trust and confidence in the Parliament.

In the post-COVID environment, the Parliament will continue to find ways to realise the benefits of new technologies, build the capacity of its Members and staff, and effectively engage with the entire community.

The preconditions for an effective Parliament identified in the Strategic Plan for the 57th Parliament continue to be essential and are to be taken as read along with the values of the parliamentary departments.
