# Children (Education and Care Services) Supplementary Provisions Bill 2011

## Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

## Overview of Bill

The object of this Bill is to provide for the regulation of certain children's education and care services that are not subject to the *Children (Education and Care Services) National Law (NSW)* (the **National Law**) and to align the regulation of those services, where practicable, with the National Law.

The children's education and care services that are the subject of the proposed Act are:

- (a) home based education and care services (other than family day care services), and
- (b) mobile education and care services, and
- (c) centre based education and care services, and
- (d) other education and care services of a kind prescribed by the regulations.

Only children's education and care services that are not regulated by the National Law are covered. These services are referred to as **State regulated education and care services**. Those services, along with those children's education and care services that are regulated under the National Law (such as family day care services), are currently regulated under Chapter 12 of the *Children and Young Persons (Care*

*and Protection) Act 1998*. That Chapter is repealed by the proposed Act. It will be replaced by the proposed Act and the National Law.

## Outline of provisions

### **Part 1 Preliminary**

**Clause 1** sets out the name (also called the short title) of the proposed Act.

**Clause 2** provides for the commencement of the proposed Act on a day or days to be appointed by proclamation.

**Clause 3** defines certain words and expressions used in the proposed Act. The *National Law Alignment Provisions* are the provisions of the National Law that apply to State regulated education and care services by virtue of the proposed Act.

**Clause 4** defines State regulated education and care service, as described in the overview.

**Clause 5** provides for exemptions from the proposed Act.

### **Part 2 Guiding principles**

**Clause 6** provides for the guiding principles of the proposed Act.

**Clause 7** provides for the role of the guiding principles.

### **Part 3 State regulated education and care services**

#### **Division 1 Operation of State regulated education and care services**

**Clause 8** makes it an offence for a person to provide a State regulated education and care service unless the person is an approved provider in respect of that service (that is, the holder of a provider approval) and the service is an approved education and care service (that is, the subject of a service approval).

**Clause 9** makes it an offence for a person to advertise an education and care service unless the person is an approved provider in respect of that service and the service is an approved education and care service.

**Clause 10** requires each approved education and care service (other than a home based education and care service) to have at least one nominated supervisor who is a certified supervisor. Contravention of this requirement is not an offence but is a contravention of the proposed Act.

## **Division 2      Provider approvals**

**Clause 11** explains that the National Law Alignment Provisions make provision for the grant of provider approvals for State regulated education and care services and other matters relating to provider approvals.

**Clause 12** makes it an offence for a person to contravene a condition of a provider approval. The penalty for the offence is aligned with the penalty for the corresponding offence under the National Law.

## **Division 3      Service approvals**

**Clause 13** explains that the National Law Alignment Provisions make provision for the grant of service approvals for State regulated education and care services and other matters relating to service approvals.

**Clause 14** makes it an offence for a person to contravene a condition of a service approval. The penalty for the offence is aligned with the penalty for the corresponding offence under the National Law.

## **Division 4      Supervisor certificates**

**Clause 15** explains that the National Law Alignment Provisions make provision for the grant of supervisor certificates for State regulated education and care services and other matters relating to supervisor certificates.

**Clause 16** makes it an offence for a person to contravene a condition of a supervisor certificate. The penalty for the offence is aligned with the penalty for the corresponding offence under the National Law.

## **Part 4      National Law alignment**

### **Division 1      Alignment with National Law**

**Clause 17** applies the National Law to State regulated education and care services as if those services were education and care services within the meaning of the National Law. The National Law applies as modified by the proposed Act and by any regulations under the proposed Act.

**Clause 18** provides for the application of the *Children (Education and Care Services National Law Application) Act 2010* in respect of the National Law Alignment Provisions.

**Clause 19** provides that the *Interpretation Act 1987* does not apply in respect of the National Law Alignment Provisions.

**Clause 20** makes it clear that authorities granted under the National Law Alignment Provisions are not authorities for the purposes of the National Law.

## **Division 2      Modification of National Law**

**Clause 21** excludes the operation of various provisions of the National Law for the purposes of the National Law Alignment Provisions.

**Clause 22** provides for references to education and care services under the National Law to be read as references to State regulated education and care services.

**Clause 23** provides for references in the National Law to the law itself to be read as references to the proposed Act and the regulations under the proposed Act.

**Clause 24** provides for references to the Regulatory Authority to mean the Regulatory Authority for this jurisdiction (that is, the Director-General of the Department of Education and Communities). The National Law Alignment Provisions do not confer powers on Regulatory Authorities of other jurisdictions.

**Clause 25** provides for references to regulations in the National Law to be read as references to regulations under the proposed Act.

**Clause 26** requires references in the National Law that relate to national scheme matters to be disregarded.

**Clause 27** contains specific variations to the National Law in relation to home based education and care services.

**Clause 28** enables the regulations to extend the list of reviewable decisions under the National Law, in relation to State regulated education and care services.

**Clause 29** enables further modifications to be made to the National Law, in its application to State regulated education and care services, by regulation.

## **Division 3      Recognition of matters provided for by National Law**

**Clause 30** provides that a person who holds a provider approval under the National Law is taken to be an approved provider of State regulated education and care services under the proposed Act. Accordingly, there is no need for an approved provider under the National Law to obtain a separate provider approval under the proposed Act in order to provide State regulated education and care services.

**Clause 31** provides that authorised officers appointed under the National Law by the Regulatory Authority for this jurisdiction are taken to be authorised officers for the purposes of the National Law Alignment Provisions.

## **Part 5      Other operational requirements**

**Clause 32** requires approved providers of State regulated education and care services to provide information about the service to parents of children enrolled in the service.

**Clause 33** requires an approved provider of a State regulated education and care service to afford parents contact with their children.

**Clause 34** requires the Regulatory Authority to be notified if an adult person is residing at the home of an approved provider of a home based education and care service for a lengthy period.

**Clause 35** requires records to be kept in relation to State regulated education and care services.

## **Part 6 Miscellaneous**

**Clause 36** enables the Governor to make regulations for the purposes of the proposed Act.

**Clause 37** enables the regulations to adopt other publications, in particular, the national regulations made under the National Law.

**Clause 38** provides that the *State Records Act 1998* does not apply in respect of certain private children's services.

**Clause 39** provides for the review of the proposed Act in 5 years.

## **Schedule 1 Savings, transitional and other provisions**

**Schedule 1** contains savings, transitional and other provisions consequent on the enactment of the proposed Act.

The provisions continue the operation of the *Children's Services Regulation 2004*, made under the *Children and Young Persons (Care and Protection) Act 1998*, as a Regulation taken to be made under the proposed Act.

## **Schedule 2 Amendment of Acts and Regulations**

**Schedule 2** amends the Acts and Regulations specified in the Schedule.

The amendments provide for the repeal of Chapters 12 and 12A of the *Children and Young Persons (Care and Protection) Act 1998* and provide for various consequential matters relating to that repeal, the commencement of the National Law and the enactment of the proposed Act.

Amendments to the *Children (Education and Care Services National Law Application) Act 2010* also:

- (a) ensure that Part 3A of the *Ombudsman Act 1974* (Child protection) continues to apply in respect of education and care services regulated under the National Law, and
- (b) update the meanings of the expression **Regulatory Authority**, **children's services law**, **education law** and **former education and care services law**, and

- (c) include an additional transitional provision in relation to nominated supervisors of approved education and care services to ensure that only one supervisor can be nominated.

An Act to regulate the provision of certain children's education and care services; to align the regulation of those services with the *Children (Education and Care Services) National Law (NSW)*; and for other purposes.

**The Legislature of New South Wales enacts:** 1

**Part 1 Preliminary** 2

**1 Name of Act** 3

This Act is the *Children (Education and Care Services) Supplementary Provisions Act 2011*. 4  
5

**2 Commencement** 6

This Act commences on a day or days to be appointed by proclamation. 7

**3 Definitions** 8

(1) In this Act: 9

***approved education and care service*** means a State regulated education and care service for which a service approval exists. 10  
11

***approved provider*** means: 12

(a) a person who holds a provider approval granted under the National Law Alignment Provisions, or 13  
14

(b) a person who is taken to be an approved provider under Division 3 of Part 4. 15  
16

***centre based education and care service***—see section 4. 17

***certified supervisor*** means a person who holds a supervisor certificate. 18

***education and care service***—see section 4. 19

***exempt premises***—see section 5. 20

***family day care service*** has the same meaning as it has in the National Law. 21  
22

***home based education and care service***—see section 4. 23

***mobile education and care service***—see section 4. 24

***National Law*** means the *Children (Education and Care Services) National Law (NSW)*. 25  
26

***National Law Alignment Provisions***—see section 17. 27

***provider approval*** means a provider approval under the National Law Alignment Provisions. 28  
29

***Regulatory Authority*** means the Regulatory Authority for this jurisdiction within the meaning of the National Law. 30  
31

***service approval*** means a service approval under the National Law Alignment Provisions. 32  
33

***State regulated education and care service***—see section 4. 34

---

*supervisor certificate* means a supervisor certificate under the National Law Alignment Provisions. 1  
2

(2) Notes included in this Act do not form part of this Act. 3

**4 Meaning of “State regulated education and care service” 4**

(1) For the purposes of this Act, each of the following education and care services is a *State regulated education and care service*: 5  
6

(a) a *home based education and care service*, being an education and care service in which the care (not being care organised or arranged by a family day care service) is provided by the carer at the home of the carer, not being the home of any of the children receiving the care (other than a child related to the carer), 7  
8  
9  
10  
11

(b) a *mobile education and care service*, being an education and care service that visits specific premises, areas or places at specified times for the purpose of providing the care, 12  
13  
14

(c) a *centre based education and care service*, being an education and care service that is provided at fixed premises (other than the home of the approved provider of the service), 15  
16  
17

(d) an education and care service of a kind prescribed by the regulations. 18  
19

(2) An *education and care service* is a service that provides education or care (other than residential care), or both education and care, whether directly or indirectly, for one or more children under the age of 6 years and who do not ordinarily attend school (disregarding any children who are related to the person providing the care). 20  
21  
22

(3) However, a *State regulated education and care service* does not include any of the following: 25  
26

(a) a service that is an education and care service within the meaning of the National Law (disregarding this Act), 27  
28

(b) a service provided by a designated agency within the meaning of the *Children and Young Persons (Care and Protection) Act 1998*, 29  
30

(c) a babysitting, playgroup or child-minding service that is organised informally by the parents of the children concerned, 31  
32

(d) a service provided for fewer than 5 children (disregarding any children who are related to the person providing the service) at the premises at which at least one of the children resides, being a service that is not advertised, 33  
34

(e) a service involving medical or clinical care provided by a hospital, 37  
38

(f)	a regular child-minding service:	1
(i)	that is provided in connection with a hospital, health service or a recreational or commercial facility, and	2
(ii)	that is provided by or on behalf of the person conducting the hospital, health service or recreational or commercial facility, and	3
(iii)	that is provided to care for children only:	4
(A)	while a sibling of the child being cared for is being treated at the hospital or health service, or	5
(B)	while the children's parents or authorised carers are visiting or being treated at the hospital or health service or are using the recreational or commercial facility,	6
(g)	a service that is concerned primarily with the provision of:	7
(i)	lessons or coaching in, or providing for participation in, a cultural, recreational, religious or sporting activity, or	8
(ii)	private tutoring,	9

(i)	a service provided at exempt premises, but only if the service is established, registered or licensed as part of the institution operating on those premises,	11
(j)	a service excluded from the operation of this Act by the regulations.	12
(4)	In this section:	13
	<b>hospital</b> means:	14
(a)	a private health facility licensed under the <i>Private Health Facilities Act 2007</i> , or	15
(b)	a declared mental health facility or a private mental health facility within the meaning of the <i>Mental Health Act 2007</i> , or	16
(c)	a public hospital within the meaning of the <i>Health Services Act 1997</i> .	17
<b>5</b>	<b>Exempt premises</b>	18
(1)	The regulations may prescribe any class of premises as exempt premises for the purposes of this Act.	19

- (2) The Minister may, by order published in the Gazette, declare any premises to be exempt premises for the purposes of specified provisions of this Act. 1

- (3) A reference in this Act to *exempt premises* is a reference to: 4
- (a) any premises belonging to a class of premises prescribed by the regulations as exempt premises, and 5

  - (b) in relation to any provision of this Act, any premises declared to be exempt premises for the purposes of that provision by an order of the Minister under this section, being an order that is in force. 7

**Part 3 State regulated education and care services** 1

**Division 1 Operation of State regulated education and care services** 2  
3

**8 Unauthorised provision of education and care service** 4

(1) A person must not provide a State regulated education and care service unless: 5  
6

(a) the person is an approved provider in respect of that service, and 7

(b) the service is an approved education and care service. 8

Maximum penalty: \$22,000. 9

(2) A certified supervisor of a State regulated education and care service who is not the approved provider of the service does not commit an offence against this section in respect of anything done in the course of supervising that service in accordance with the supervisor certificate. 10  
11  
12  
13

(3) An employee or other person who provides or assists in providing a State regulated education and care service (other than a certified supervisor of the service) does not commit an offence against this section if the employee or other person is acting in accordance with directions given by the approved provider of the service or a certified supervisor of the service. 14  
15

**9 Advertising of unauthorised education and care service** 20

(1) A person must not advertise or hold out that the person is willing to provide a State regulated education and care service unless: 21  
22

(a) the person is an approved provider in respect of the service concerned, and 23  
24

(b) the particular service being advertised is an approved education and care service. 25  
26

Maximum penalty: \$550. 27

(2) A person must not knowingly publish any advertisement inviting the attendance of children at a State regulated education and care service that is not an approved education and care service. 28  
29  
30

Maximum penalty: \$550. 31

(3) A person is not guilty of an offence under this section if: 32

(a) the State regulated education and care service is a service that is proposed to be provided in the future, and 33  
34

- (b) the person has duly applied for any provider approval or service approval required to authorise the person to provide the proposed State regulated education and care service, and 1  
2  
3
- (c) the application has not been finally determined. 4

**10 Nomination of supervisor** 5

- (1) An approved provider of an approved education and care service must ensure that there is at least one nominated supervisor of the approved education and care service. 6  
7  
8
- (2) The person nominated must be a person authorised by his or her supervisor certificate to supervise the operation of the approved education and care service or type of approved education and care service concerned. 9  
10  
11  
12
- (3) A contravention of this section is a contravention of a provision of this Act. 13  
14
- (4) A nominated supervisor is not required in respect of a home based education and care service. 15  
16
- (5) In this section:  
*nominated supervisor* has the same meaning as it has in the National Law Alignment Provisions. 17

**Division 2 Provider approvals** 20

**11 Provider approvals** 21

The National Law Alignment Provisions provide for the grant of provider approvals for State regulated education and care services and other matters relating to provider approvals. 22  
23  
24

**Note.** See also Division 3 of Part 4, which provides for the recognition, for the purposes of this Act, of provider approvals granted under the National Law. 25  
26

**12 Contravention of provider approval** 27

An approved provider must not contravene a condition of a provider approval granted under the National Law Alignment Provisions. 28  
29

Maximum penalty: \$10,000 in the case of an individual or \$50,000 in any other case. 30
