(2) In addition to the conditions imposed by the Authority, it is a condition of an aircraft (pesticide applicator) licence that the holder of the licence must notify the Authority of any incident where a pesticide leakage or spill has occurred as the result of a crash or forced landing of an aircraft that is operated under the authority of the licence. Such notice must be given as soon as practicable after the incident occurs.
