(a) the suspension of a councillor or Board member from office under Division 3A of Part 10 of the <i>Aboriginal Land Rights Act 1983</i> , or	7
(b) the taking of action against a member of staff of an Aboriginal Land Council under that Division.	8
(2) The Commission is not to make a recommendation under this section unless the Commission is of the opinion that prompt action is required in the public interest.	9
(3) This section does not limit any other recommendation that the Commission is authorised to include in a report under section 74 in relation to a councillor, Board member or member of staff.	10
(4) This section extends to a report in relation to a matter that has been the subject of an investigation conducted before the commencement of this section.	11
