# Appropriation (Parliament) Bill 2023

## Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

This Bill is cognate with the *Appropriation Bill 2023*.

## Overview of Bill

The object of this Bill is to appropriate from the Consolidated Fund a sum for the services of the Legislature for the 2023–24 financial year, including capital works and services, recurrent services and the repayment of debt.

## Outline of provisions

### Part 1 Preliminary

**Clause 1** sets out the name, also called the short title, of the proposed Act.

**Clause 2** provides for the commencement of the proposed Act.

**Clause 3** defines certain terms used in the proposed Act.

### Part 2 Appropriation for Legislature

**Clause 4** provides for the appropriation, out of the Consolidated Fund, to the Legislature for the services of the Legislature for the 2023–24 financial year.

### **Part 3   General**

**Clause 5** provides that certain payments made from the Consolidated Fund on or after 1 July 2023 pending the enactment of the proposed Act are deemed to be made out of the sums appropriated by the proposed Act.



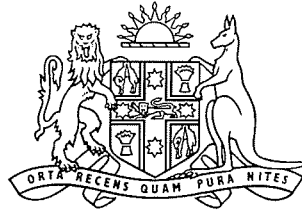

This Act appropriates the sum of \$231,945,373 to the Legislature out of the Consolidated Fund for the services of the Legislature for the year 2023–24.

**Note—** The appropriation, together with funds from other sources, is intended to fund—

(a) expenses to the sum of \$234,158,940, and

(b) capital expenditure to the sum of \$43,864,000.

An amount is taken to have been expended out of a sum appropriated for a purpose by this Act if the amount—

(a) was paid for the purpose out of the Consolidated Fund under the *Government Sector Finance Act 2018*, section 4.10, and

(b) was paid on or after 1 July 2023 and before the date of assent to this Act.
