# Centennial Park and Moore Park Trust Amendment (Public Transport) Bill 2023

## Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

## Overview of Bill

The object of this Bill is to amend the *Centennial Park and Moore Park Trust Act 1983* to confer on the Minister for Transport a permanent licence over certain land for public transport purposes and ancillary purposes.

## Outline of provisions

**Clause 1** sets out the name, also called the short title, of the proposed Act.

**Clause 2** provides for the commencement of the proposed Act.

**Schedule 1** contains amendments to give effect to the object of the Bill.
