## David Berry Hospital Amendment (Prohibition of Sale) Bill 2024

### **Explanatory note**

This explanatory note relates to this Bill as introduced into Parliament.

#### Overview of Bill

The object of this Bill is to prohibit the sale or disposal of the lands on which the David Berry Hospital stands.

### Outline of provisions

Clause 1 sets out the name, also called the short title, of the proposed Act.

Clause 2 provides for the commencement of the proposed Act on the date of assent to the proposed Act.

### Schedule 1 Amendment of David Berry Hospital Act 1906 No 53

**Schedule 1** provides that the Crown, or another person, must not sell or dispose of lands vested in the Crown under the *David Berry Hospital Act 1906* and used as the site of the David Berry Hospital.
