### **A Bill for**

An Act to amend the *Public Health (Tobacco) Act 2008* and the *Public Health (Tobacco) Regulation 2022* to establish a licensing scheme to regulate the sale of tobacco products and non-tobacco smoking products; to provide for clearer offences relating to the display of prices and brands and to increase penalties for particular offences; and for related purposes.

**1 Name of Act**

This Act is the *Public Health (Tobacco) Amendment Act (No 2) 2024*.

**2 Commencement**

This Act commences as follows—

- (a) for Schedule 1[2]–[8], [11] and [12] and Schedule 2—on the date of assent to this Act,
- (b) otherwise—on a day or days to be appointed by proclamation.

  - (b) a wholesale licence. 14
- (2) An application may not be made by an individual who is under the age of 18 years. 15

  - (a) be in the approved form, and 18
  - (b) be accompanied by the fee, if any, prescribed by the regulations for the application, and 19

  - (c) state the type of licence being applied for, and 21
  - (d) state the applicant's name and business address, and 22
  - (e) for an application for a retail licence— 23
    - (i) if the applicant proposes a single retail premises be specified as the licensed retail outlet for the retail licence—state the address of the retail premises, and 24

    - (ii) if the applicant proposes a single website be specified as the licensed online retail shop for the retail licence—include the details of the website, and 27

  - (b) any other matters prescribed by the regulations. 10
- (3) Despite subsection (1), the Secretary may refuse to decide the application if 11

  - (a) does not comply with a requirement to give information under section 13

  - (b) fails to notify the Secretary of a change in information under section 15

#### **Subdivision 4 Applications for renewal of licences** 37

##### **39B Applications to renew licences** 38

- (1) A licence holder may, before the expiry of the licence, apply to the Secretary 39  
to renew the licence. 40
- (2) Despite subsection (1), the Secretary may accept an application to renew a 41  
licence made within 30 days after the expiry of the licence if the Secretary is 42  
satisfied it is reasonable to accept the application in the circumstances. 43

- (a) be in the approved form, and 1
