Appropriation (Parliament) Bill 2025

Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

This Bill is cognate with the *Appropriation Bill 2025*.

Overview of Bill

The object of this Bill is to appropriate from the Consolidated Fund a sum for the services of the Legislature for the 2025–26 financial year (the ***appropriation year***), including capital works and services, recurrent services and the repayment of debt.

Outline of provisions

Part 1 Preliminary

Clause 1 sets out the name, also called the short title, of the proposed Act.

Clause 2 provides for the commencement of the proposed Act.

Clause 3 defines certain terms used in the proposed Act.

Part 2 Appropriation for Legislature

Clause 4 provides for the appropriation, from the Consolidated Fund, to the Legislature for the services of the Legislature for the appropriation year.

Part 3 General

Clause 5 deems certain payments made from the Consolidated Fund during the appropriation year and before the enactment of the proposed Act to be payments made from the sum appropriated by the proposed Act.
