# Workers Compensation Amendment (Firefighters' Diseases) Bill 2025

## **Explanatory note**

This explanatory note relates to this Bill as introduced into Parliament.

#### Overview of Bill

The object of this Bill is to amend the Workers Compensation Act 1987 as follows—

- (a) to specify further kinds of cancer as diseases to which presumptive rights to compensation for firefighters apply and to specify the corresponding qualifying service periods,
- (b) to reduce the qualifying service period for primary site oesophageal cancer from 25 years to 15 years.

## Outline of provisions

Clause 1 sets out the name, also called the short title, of the proposed Act.

Clause 2 provides for the commencement of the proposed Act on the date of assent to the proposed Act.

#### Schedule 1 Amendment of Workers Compensation Act 1987 No 70

**Schedule 1[1] and [2]** amend the *Workers Compensation Act 1987*, Schedule 4 to give effect to the object set out in the overview above.

**Schedule 1[3]** inserts provisions of a savings or transitional nature.
