Coal and Oil Shale Mine Workers (Superannuation) Amendment (Age Discrimination) Bill 1997

Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

Overview of Bill

The object of this Bill is to remove compulsory retirement ages applicable to mine workers under the *Coal and Oil Shale Mine Workers (Superannuation)* Act 1941, to remove age limits on employment of mine workers and to make consequential amendments to that Act relating to superannuation benefits and other matters.

Explanatory note

Outline of provisions

Clause 1 sets out the name (also called the short title) of the proposed Act.

Clause 2 provides for the commencement of the proposed Act on the date of assent.

Clause 3 is a formal provision giving effect to the amendments to the *Coal* and *Oil Shale Mine Workers (Superannuation) Act 1941* set out in Schedule 1.

Schedule 1 Amendments

Removal of mandatory retirement provisions

The amendments remove the requirements under the *Coal and Oil Shale Mine Workers (Superannuation)* Act 1941 that mine workers retire at age 60 or at other ages (up to age 65) specified under the Act or determined by the Corporate Trustee under the Act (see Schedule 1 [5]–[8]).

The amendments also make it clear that mine workers will still be able to voluntarily retire at age 60 and that the removal of compulsory retirement will not affect superannuation benefits (see Schedule 1 [5], proposed section 5).

Consequential amendments are made by Schedule 1 [1]-[4] and [9].


