# Gaming Machines Amendment (Transparency) Bill 2017

## Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

## Overview of Bill

The object of this Bill is to require the publication, at regular intervals, of certain information relating to the operation of gaming machines at each hotel or club in respect of which a gaming machine entitlement is held.

## Outline of provisions

**Clause 1** sets out the name (also called the short title) of the proposed Act.

**Clause 2** provides for the commencement of the proposed Act on the date of assent to the proposed Act.

## A Bill for

An Act to amend the *Gaming Machines Act 2001* to make further provision with respect to reporting by licensed premises on gaming machine operations; and for other purposes.

---

**The Legislature of New South Wales enacts:**

**1 Name of Act**

This Act is the *Gaming Machines Amendment (Transparency) Act 2017*.

**2 Commencement**

This Act commences on the date of assent to this Act.

<b>140B Authority to publish certain CMS information</b>	3
(1) As soon as practicable after the end of each month, the Authority is to cause to be published, on a publicly available website, a report including the following information in relation to each hotel or club in respect of which a gaming machine entitlement is held for that month:	4
(a) the address of the hotel or club, including the local government area and the classification of the local government area under section 33,	5
(b) the number of gaming machines at the hotel or club,	6
(c) the gaming machine threshold for the hotel or club,	7
(d) the total value of all bets made by players of gaming machines at the hotel or club during that month,	8
(e) the total profits from all gaming machines at the hotel or club during that month.	9
(2) As soon as practicable after the end of each quarter of each financial year, the Authority is to publish, on a publicly available website, a report including the following information in relation to each club in respect of which a gaming machine entitlement is held for that quarter:	10
(a) the value of each contribution constituting an application of profits to community development and support (within the meaning of Part 4 the <i>Gaming Machine Tax Act 2001</i> ) made during that quarter,	11
(b) the date of each contribution,	12
(c) the recipient of each contribution,	13
(d) the category (within the meaning of that Part) of each contribution.	14
