# Statute Law (Miscellaneous Provisions) Bill 2017

## Explanatory note

This explanatory note relates to this Bill as introduced into Parliament.

## Overview of Bill

The objects of this Bill are:

- (a) to make minor amendments to various Acts and instruments (Schedule 1), and
- (b) to amend certain other Acts and instruments for the purpose of effecting statute law revision (Schedule 2), and
- (c) to repeal various Acts and provisions of Acts and an instrument (Schedule 5), and
- (d) to make other provisions of a consequential or ancillary nature (Schedules 3, 4 and 6).

## Outline of provisions

**Clause 1** sets out the name (also called the short title) of the proposed Act.

**Clause 2** provides for the commencement of the proposed Act.

**Clause 3** makes it clear that the explanatory notes contained in the Schedules do not form part of the proposed Act.

	Item [2] removes the requirement that the membership of the Carers Advisory Council (which advises the Minister for Disability Services ( <i>the Minister</i> ) on matters relating to carers) include the Minister and other Ministers responsible for the provision of support services to carers. Instead, the Council is required to comprise persons who have relevant knowledge of and experience in matters relevant to carers (the <i>appointed members</i> ). Item [2] also provides that the Minister must appoint 2 of the appointed members as Chair and Deputy Chair of the Council. #### Explanatory note 41

The proposed amendments more clearly delineate the ambit of provisions of the *Charles Sturt University Act 1989 (the Act)* that confer powers on the Council of the University (*the Council*) with 42  
respect to the control and management of the financial affairs of the University and the acquisition 43

and management of property. The powers concerned are exercisable by the Council subject to the duties imposed on the Council under Schedule 3 to the Act. Similar amendments are being made to university Acts in general.	1 2 3
