(c) to ensure that Infrastructure NSW exercises its functions consistently with the principles of ecologically sustainable development contained in section 6 (2) of the *Protection of the Environment Administration Act 1991*.

(c) a person appointed by the Premier with experience in non-government community organisations and in social inclusion,

(n) to regularly report to Parliament on the progress and delivery of infrastructure and the conduct of its operations.

(2) The financial reports and records of any partnership, joint venture or other association between Infrastructure NSW and a non-government person or body that relate to any infrastructure project are to be audited by the Auditor-General at least once every calendar year.
(3) The Auditor-General is to provide the Premier with a report on the results of each such audit and the Premier must table the report, or cause it to be tabled, in both Houses of Parliament within 14 sitting days of its receipt.

The annual report of Infrastructure NSW must include the following:

- (a) the status of current major infrastructure projects,
