## **Property (Relationships) Legislation Amendment Bill 1999**

Act No     , 1999

---

An Act to amend the *De Facto Relationships Act 1984* to extend the provisions of that Act so that they apply to parties to relationships of a more widely-defined class; to amend certain Acts that confer rights or impose obligations with respect to married persons or persons in a de facto relationship; and for other purposes.

- (4) Except as provided by section 6, a reference in this Act to a party to a de facto relationship includes a reference to a person who, whether before or after the commencement of this subsection, was a party to such a relationship. 8

## 5 Domestic relationships 13

- (1) For the purposes of this Act, a domestic relationship is: 14
- (a) a de facto relationship, or 15
- (b) a close personal relationship (other than a marriage or a de facto relationship) between two adult persons, whether or not related by family, who are living together, one or each of whom provides the other with domestic support and personal care. 16

- (2) For the purposes of subsection (1) (b), a close personal relationship is taken not to exist between two persons where one of them provides the other with domestic support and personal care: 21

- (a) for fee or reward, or 25
- (b) on behalf of another person or an organisation (including a government or government agency, a body corporate or a charitable or benevolent organisation). 26

- (3) A reference in this Act to a child of the parties to a domestic relationship is a reference to any of the following: 30

- (a) a child born as a result of sexual relations between the parties, 32

- (b) a child adopted by both parties, 34
- (c) where the domestic relationship is a de facto relationship between a man and a woman, a child of the woman: 35

- (i) of whom the man is the father, or 1
- (ii) of whom the man is presumed, by virtue of 2  
the *Status of Children Act 1996*, to be the 3

**5A Family relationship** 14

- (1) For the purposes of sections 4 and 5, persons are related by 15

  - (c) they have a parent in common. 20

**Explanatory note**

The amendment affects the operation of section 45 of the *Trustee Act 1925*, which deals with income that is the subject of a protective trust. If the trust fails before expiry, there is a resulting trust in favour of the wife or husband of the principal beneficiary, or his or her children and their descendants. The amendment substitutes "spouse", in the sense defined in proposed section 45 (11), for "wife or husband" and inserts a new definition of *child*.
