IN pursuance of the power and authority vested in me as such Governor aforesaid, by virtue of an Act passed in the second year of the reign of his late Majesty King Edward the Seventh, being "An Act to consolidate the Acts relating to the Constitution": I do hereby proclaim that a session of the Legislative Council and Legislative Assembly for the State of New South Wales for the despatch of business shall commence and be holden on Wednesday, the twenty-sixth day of April instant, at twelve o'clock at noon, in the buildings known as the Legislative Council Chambers, in Macquarie-street, in the city of Sydney; and members of the said Legislative Council and Legislative Assembly, respectively, are hereby required to give their attendance at the said time and place accordingly.

Given under my hand and seal, at Sydney, this nineteenth day of April, in the year of our Lord one thousand nine hundred and twenty-two, and in the twelfth year of his Majesty's reign.

#### INCOME-TAX ACT (GEO. V, No. 1, 1922)—

An Act to provide for an increase of income-tax; and for this purpose to amend the Income-tax Act, 1911, and certain other Acts. [Initiated in the Assembly by Mr. Cocks, 26 April, 1922. Assented to, 28 April, 1922.]

#### PARLIAMENTARY ALLOWANCES AND SALARIES ACT (GEO. V, No. 2, 1922)—

An Act to reduce the allowances to members of the Legislative Assembly and the salaries of Ministers of the Crown and of certain other persons; to amend the Constitution Act, 1902, the Ministers' Salaries Act, 1908, the Parliamentary Representatives' Allowance Act, 1912, the Parliamentary Representatives' Allowance and Ministers' Salaries (Amendment) Act, 1920, and certain other Acts; and for other purposes. [Initiated in the Assembly by Mr. Cocks, 26 April, 1922. Assented to, 6 May, 1922.]

*Parliamentary Allowances and Salaries Bill:* It would be extremely inconvenient for the Speaker to take notice of statements made by members across the floor during a division; the Speaker could not constitute himself a tribunal to decide between conflicting versions of what had been said, 117; the bill was not a question in which members had the direct pecuniary interest contemplated by standing order 204; in interpreting the standing orders, the Speaker when in doubt could not construe them in such a way as to lead to an obvious absurdity; it would be utterly repugnant to one's common-sense to rule that the House had no right to pass a measure relating to the salaries of members, 148; the proceedings of Parliament were regulated not only by standing orders but also by ancient usage and established practice and the standing orders, important and binding as they were, did not in any sense constitute a codification of the law of Parliamentary procedure. The rule in regard to personal interest was established in the House of Commons over 200 years ago, and broadly stated was that no member who had a pecuniary interest in a question should be allowed to vote upon it, but in order to operate as a disqualification the interest must be immediate and personal and not of a general or remote character. The bill was clearly a matter of State policy within the meaning of the rule explained by Mr. Speaker Abbott, and invariably followed in the House of Commons and in the Parliaments of other parts of the British Dominions. Therefore, the disqualification from voting referred to in standing order 204 did not apply to the bill, 150; the motion "That the bill do now pass," was a purely formal motion, and had been dispensed with in the House of Commons. No detailed discussion could be allowed on this motion or on the motion "That the title of the bill be, &c." The discussion would have to be strictly confined to reasons why the bill should not pass, seeing that the third reading had already been carried, 226; there was urgent need for new standing orders, which would dis-
