Governor: Commonwealth of Australia.

WHEREAS the Parliament of New South Wales now stands prorogued until Tuesday, the ninth day of February, 1926; and whereas by an Act passed in the second year of the reign of His late Majesty King Edward the Seventh, being "an Act to consolidate the Acts relating to the Constitution," it is amongst other things enacted that the Governor may fix the time and place for the holding of every session of the Legislative Council and Assembly : Now, therefore, I, Sir DUDLEY RAWSON STRATFORD DE CHAIR, Governor, do hereby announce and proclaim that the said Legislative Council and Assembly shall assemble for the dispatch of business on the aforesaid ninth day of February next, at 12 o'clock, at noon, in the buildings known as the Legislative Council Chambers, situate in Macquarie-street, in the City of Sydney : And the Members of the Legislative Council and Legislative Assembly, respectively, are hereby required to give their attendance at the said time and place accordingly.

Given under my hand and seal, at Sydney, this second day of February, in the year of our Lord one thousand nine hundred and twenty-six, and in the sixteenth year of his Majesty's reign.
