G. STRICKLAND, of New South Wales and its Dependencies, in the Commonwealth

IN pursuance of the power and authority vested in me as such Governor aforesaid, by virtue of an Act passed in the second year of the reign of His late Majesty King Edward the Seventh, being "An Act to consolidate the Acts relating to the Constitution": I do hereby proclaim that a session of the Legislative Council and Legislative Assembly for the State of New South Wales, for the despatch of business, shall commence and be holden on Tuesday, the twenty-third day of December instant, at twelve o'clock at noon, in the buildings known as the Legislative Council Chambers, in Macquarie-street, in the City of Sydney; and Members of the said Legislative Council and Legislative Assembly, respectively, are hereby required to give their attendance at the said time and place accordingly.

Given under my hand and seal, at Sydney, this sixteenth day of December, in the year of our Lord one thousand nine hundred and thirteen, and in the fourth year of his Majesty's reign.
