vacancies in Parliament elected on system of proportional representation-

Clause 7. Notwithstanding anything contained in this Act or the Principal Act or any redistribution of the boundaries of electoral districts, if a member of any Parliament of the State which is, either before or after the commencement of this Act, elected in accordance with the principles of proportional representation, ceases to be a member by death, resignation, or otherwise, the casual vacancy so occasioned shall be filled in accordance with the provisions of the Parliamentary Elections (Casual Vacancies) Act, 1920, and the Parliamentary Elections (Casual Vacancies) Amendment Act, 1921; and for the purposes of the said Acts, the constituency for which the vacancy has occurred shall be deemed to be the electoral district in respect of which such Member was elected, as bounded at date of the commencement of this Act.
