1. OPENING OF THE SESSION:—The House met at Twelve o'clock, at Noon, pursuant to a Proclamation of His Excellency the Governor, bearing date the seventh day of November, 1884.

Mr. Speaker took the Chair.

The Clerk, by direction of Mr. Speaker, read a copy of the said Proclamation, as follows:-

"Whereas the Parliament of New South Wales now stands prorogued to Tuesday, the eighteenth day " of November instant: Now I, Lord Augustus William Frederick Spencer Loftus, in pursuance "of November instant: Now I, Lord Augustus William Frederick Spencer Loftus, in pursuance "of the power and authority in me vested as Governor of the said Colony, do hereby further "prorogue the said Parliament to Wednesday, the nineteenth day of November instant: And I do "hereby further announce and proclaim that the said Parliament shall assemble for the despatch of Business on the aforesaid nineteenth day of the current month, at Twelve o'clock, at Noon, in the buildings known as the Council Chambers, situate in Macquarie-street, in the City of Sydney: And the Members of the Legislative Council and Legislative Assembly respectively are thereby required to give their attendance at the said time and place accordingly. "Given under my Hand and Seal, at Government House, Sydney, this seventh day of "November, in the year of our Lord one thousand eight hundred and eighty-four, and "in the forty-eighth year of Her Majesty's Reign.

- VACANT SEATS:—Mr. Speaker informed the House that during the recess Sir Henry Parkes, K.C.M.G., Member for the Electoral District of Tenterfield, had resigned his Seat; and that Andrew Lynch, Esquire, one of the Members for the Electoral District of Carcoar, had died; that thereupon, in accordance with the direction of the 17th clause of the Electoral Act of 1880, he had issued Writs for the Election of Members to serve in the room of Sir Henry Parkes and Andrew Lynch, Esquire, respectively.
- 3. Message from the Commissioners:—The Usher of the Black Rod being admitted, delivered a Message, that "The Commissioners request the immediate attendance of this Honorable House in "the Legislative Council Chamber, to hear the Commission for opening Parliament read."

"WHEREAS, by Proclamation, made on the seventh day of November instant, His Excellency the "Right Honorable Lord Augustus William Frederick Spencer Lortus, Knight Grand Cross " of our Most Honorable Order of the Bath, our Governor and Commander-in-Chief of our Colony

"of New South Wales, did, in pursuance of the power and authority vested in him as Governor and Commander-in-Chief of our said Colony, by virtue of the Act of the late Legislature thereof, intituled 'An Act to confer a Constitution on New South Wales and to grant a Civil List to 'Her Majesty,' as assented to by us, proclaim that a Session of the Legislative Council and Legislative Assembly, constituted under the said Act, and composing the Parliament of our said 'Colony of New South Wales, should commence and be holden on Wednesday, the nineteenth day of November instant: And whereas, for certain causes, our said Governor and Commander-in-Chief cannot conveniently be present in person at the opening of the said Session: Now know ye, that we, trusting in the discretion, fidelity, and care of our trusty and well-beloved the Honorable Sir John Hay, K.C.M.G., President of the said Legislative Council, the Honorable William Bede Dalley, Q.C., Attorney General, and Acting Colonial Secretary, and the Honorable Archibald Hamilton Jacob, Members of the said Legislative Council; do, with the advice of our Executive Council of our said Colony, give and grant by the tenor of these presents unto the said Sir John Hay, William Bede Dalley, and Archibald Hamilton Jacob, so being such President and Members of the said Legislative Council, or any two of them, full power in our name to open and hold the said Session of the said Legislative Council and Legislative Assembly on the said nineteenth day of November, on our behalf, and to do all things necessary to be done in our name, or in the name of our Governor of our said Colony, in and about the opening and holding of the said Session: Commanding also by the tenor of these presents all whom it concerns to meet in the said Session, that to the said Sir John Hay, William Bede Dalley, and Archibald Hamilton Jacob, or any two of them, they diligently attend in the premises in the form aforesaid.

"In testimony whereof we have caused these our Letters to be made Patent, and the Great "Seal of our said Colony to be hereunto affixed.

"Witness, our right trusty and well-beloved Councillor, SIR AUGUSTUS WILLIAM FREDERICK
"Spencer Loftus (commonly called Lord Augustus Loftus), Knight Grand Cross of

"this eighteenth day of November, in the forty-eighth year of our Reign, and in the

The President then said:—"Honorable Gentlemen of the Legislative Council, and Gentlemen of "the Legislative Assembly,—We, the Commissioners appointed by His Excellency the Governor under the Commission you have just heard, do now proceed to acquaint you with the causes for "which this Parliament has been called together, and to read to you the Speech entrusted to us "by His Excellency for this purpose."

The President then read the Governor's Opening Speech,—and said, "Having heard His Excel"lency's Speech read, it will now be for you Honorable Gentlemen of the Legislative Council, and
"Gentlemen of the Legislative Assembly, to take the matters submitted to you, and such other
"matters as in your wisdom you may deem fit, into your grave consideration, in those places in
"which you are appointed to sit."

And the House having returned,—adjourned, on motion of Mr. Dibbs, at twenty minutes after Twelve o'clock, until Four o'clock This Day.

The House met at Four o'clock, pursuant to adjournment.

- 4. ORDNANCE LANDS TRANSFER BILL:—Mr. Dibbs presented a Bill, intituled "A Bill for confirming the transfer to the Secretary at War in England from the Principal Officers of Ordnance there of certain Lands in New South Wales and for amending the Ordnance Land Act of Council 1840,"—which was read a first time pro forma.
- 5. The Governon's Openine Speech:—Mr. Speaker reported that the House had been at the Legislative Council Chamber, at the desire of the Commissioners appointed under the Great Seal of the Colony for holding this Session of the present Parliament, and that the President of the Council, being one of the said Commissioners, delivered the Opening Speech of His Excellency the Governor to both Houses of Parliament, in pursuance of His Excellency's commands, and of which Mr. Speaker said he had, for greater accuracy, obtained a copy,—which he read to the House as follows:—

HONORABLE GENTLEMEN OF THE LEGISLATIVE COUNCIL, AND GENTLEMEN OF THE LEGISLATIVE ASSEMBLY,—

We are commanded by His Excellency the Governor to inform you that you have been called together so soon after the close of the late protracted Session for the purpose of making the necessary provision for the Services of the forthcoming year. The adoption of this course justifies the expectation that you will be permitted to enjoy a reasonable recess before you are called upon to undertake the legislative business of the year, and that His Excellency's Advisers will be enabled to mature the measures which will be then submitted to you.

- 2. As it is desirable that you should be enabled after your late arduous duties to resume your ordinary avocations without delay, the Estimates of Expenditure for the forthcoming year will be at once submitted for your consideration.
- 3. These have been prepared with strict economy, and as nearly as possible in accordance with those which you have sanctioned for the present year.

And Mr. See having brought up the Address prepared by the Committee, the same was read by the Clerk, by the direction of Mr. Speaker, as follows:—

To His Excellency the Right Honorable Lord Augustus William Frederick Spencer Loftus, Knight Grand Cross of the Most Honorable Order of the Bath, a Member of Her Majesty's Most Honorable Privy Council, Governor and Commander-in-Chief of the Colony of New South Wales and its Dependencies.

MAY IT PLEASE YOUR EXCELLENCY,-

We, Her Majesty's loyal and dutiful subjects, Members of the Legislative Assembly of New South Wales, desire to express our loyalty and attachment to Her Most Gracious Majesty's Person and Government, and offer our respectful thanks for the Speech which you have caused your Commissioners to pronounce.

We shall without delay take into our consideration the Estimates of Expenditure with a view to making adequate provision for the Public Service for the coming year.

Mr. See then moved, and Mr. William Clarke seconded the motion, That the Address in reply to the Governor's Opening Speech, as read by the Clerk, be now adopted by this House. Debate ensued.

Address in Reply to Governor's Opening Speech:—Mr. Speaker informed the House that he had been to Government House, and there presented to the Governor their Address in reply to His Excellency's Speech on opening the Session,—and that His Excellency had been pleased to give thereto the following answer:—

Mr. Speaker, and Gentlemen of the Legislative Assembly,-

I thank you for your Address renewing the expression of your loyalty and devotion to the Queen's Person and Throne. While I regret that after the late protracted Session you should have been so soon again called upon to resume your labours, I confidently rely on your wisdom and patriotism in the discharge of your duties.

- 10. MINISTERIAL STATEMENT: -- Mr. Dibbs made a Ministerial Statement, informing the House of the course the Government proposed to pursue in dealing with the business of the Session.

Business Days.—Precedence of Government Business (Sessional Order):—Mr. Dibbs moved, pursuant to Notice, That, unless otherwise ordered, this House shall meet for the dispatch of Business at Four o'clock p.m. on Tuesday, Wednesday, Thursday, and Friday, in each week, and that Government Business shall take precedence of General Business on each day. Question put and passed.
- 12. MEETING OF THE HOUSE (Sessional Order) -Mr. Dibbs moved, pursuant to Notice, That it be a Sessional Order of this House that the Bell be rung two minutes prior to Mr. Speaker taking the Chair.

QUESTIONS AND ANSWERS (Sessional Order):—Mr. Dibbs moved, pursuant to Notice, That the Clerk of the House shall enter upon the Minutes of the Votes and Proceedings the Questions, of which formal notice shall have been given, put to the Members representing the Government in this House, and the Answers returned to the same. Question put and passed.

14. FORMAL BUSINESS (Sessional Order):—Mr. Dibbs moved, pursuant to Notice, That it shall be a Sessional Order of this House,—

(1.) That every Motion or Order of the Day for the third reading of a Bill to which, on the Question being put from the Chair, "Whether there is any objection to its being a 'Formal' Motion," "or Order of the Day," no objection shall be taken, shall be deemed to be a "Formal" Motion or Order of the Day.

(2.) That before the ordinary business of each day shall be entered upon, Mr. Speaker shall call over the various Notices of Motions and Orders of the Day for third reading of Bills; and on any such Motion or Order being called, it shall be competent for the Member otherwise entitled to move it to have the above question put with reference thereto, and such "Formal" Motions or Orders of the Day shall be disposed of in the relative order in which they stand on the Business Paper taking precedence of all the other Motions and Orders of the Day.

(3.) That no Debate shall be allowed upon any such "Formal Motions or Orders of the Day," or upon the further proceedings consequent on the reading of such Orders; but the House may proceed to division thereupon, without amendment or debate, as in the case of the motion for the

first reading of a Bill. (4.) That in consequence of any such "Formal" Orders of the Day having been disposed of as aforesaid, it shall not be held that the House has proceeded to the Orders of the Day upon the Business Paper so as to exclude thereafter the presentation of Petitions or the reception of Notices of Motions.

(5.) That no motion for the appointment of a Select Committee, excepting upon a Private Bill shall be held to be a "Formal" Motion. Question put and passed.

STANDING ORDERS COMMITTEE (Sessional Order):—Mr. Dibbs moved, pursuant to Notice, That the Standing Orders Committee for the present Session shall consist of Mr. Speaker, Mr. Wisdom, Sir Patrick Jennings, Mr. Garrett, Mr. Stephen, Mr. Poole, Mr. Cameron, Mr. Heydon, Mr. Griffiths, and the Mover, with leave to sit during any adjournment, and authority and power to send for persons, papers, and records, and to examine witnesses, and to report in any matter or thing referred to or pending before the said Committee, and to confer upon subjects of mutual concernment with any Committee appointed for similar purposes by the Legislative Council.

- 22. Refreshment Committee (Sessional Order):—Mr. Dibbs moved pursuant to Notice, That a Refreshment Committee be appointed for the present Session, to consist of Mr. R. B. Smith, Mr. Cameron, Mr. Frendin, Mr. White, Mr. Farnell, Mr. W. R. Campbell, Mr. McLaughlin, Mr. Trickett, Mr. Purves, and the Mover, with leave to sit during any adjournment, and authority to act in matters of mutual concernment with any Committee appointed for similar purposes by the Legislative Council.

- 23. Printing Petitions (Sessional Order):—Mr. Dibbs moved, pursuant to Notice, That it be a Sessional Order of this House that the Clerk of the House shall cause to be printed, as a matter of course, all Petitions received by this House (excepting Petitions for the introduction of Private Bills), unless it be otherwise ordered by the House: Provided that when several Petitions are presented substantially to the same effect, he shall cause to be printed only the one first presented, to which he shall append a statement of the number of other Petitions, the general designation of the party or parties to each, and the number of signatures attached.

EXCLUSION OF STRANGERS (Sessional Order):—Mr. Dibbs moved, pursuant to Notice, That it be a Sessional Order of this House,—That when the Speaker, or the Chairman of Committees, as the case may be, has been notified by any Honorable Member that Strangers are present, then, unless four other Honorable Members rise in their places, in token of their support to the objection, no order shall be made for Strangers to withdraw: Provided that the Speaker, or the Chairman of Committees, may, whenever he thinks fit, order the withdrawal of Strangers from any part of the House.

The Clerk shall have before him a complete printed List of the Members of the House, and on the presentation of any Balloting Paper shall place his initials against the entry in such List of the name of the Member presenting such Balloting Paper, and the Clerk shall place such List so initialled on record with the other proceedings of the Ballot.

1. The House met pursuant to adjournment: Mr. Speaker took the Chair.

(1.) Railway to Racecourse on Elizabeth Farm Estate: -Mr. Hugh Taylor asked the Secretary for Public Works,—Has any application been made by petition or otherwise to the Government to construct a Branch Line of Railway from the Main Western Line, near Granville, to the New Racecourse on the Elizabeth Farm Estate, near Parramatta; if so, is it the intention of the Government to carry out the same?

Mr. Wright answered,—Yes; such an application has been made, those interested guaranteeing 10 per cent. interest upon the outlay. The question is under consideration.

(4.) Road to Parkes: -Mr. T. R. Smith, for Mr. Hugh Taylor, asked the Secretary for Public Works

(1.) Will be lay upon the Table of the House a copy of the contract made with one Raphael for the repairs of the road to Parkes, 2 miles on the other side of Molong?

(2.) Will he ask for a report from the Road Superintendent of the district as to the present condition of this work, or as to whether it has ever been properly or is now properly blinded?

(3.) Are the specifications for road contracts drawn up by the Road Superintendents of the

- district, or is there a regular printed form used by the Road Department?
- (4.) Do Road Superintendents alone recommend or decide which contract shall be accepted? (5.) Must they accept the lowest tender, provided all tenderers are alike responsible persons?

Mr. Dibbs answered,-

(1.) Yes. (2.) Yes.

(3.) Regular printed forms are used, with blanks to be filled in.
(4.) They recommend and forward papers to Commissioner for Roads, who recommends for approval of Minister.

(5) The Minister is not bound to accept the lowest or any tender, but the invariable practice is to accept the most eligible.

(5.) International Inventions Exhibition: -Mr. Burns asked the Colonial Treasurer, -Whether it is the intention of the Government to take any, and if any what, steps towards securing the representation of the Colony at the International Inventions Exhibition which is to be held in London in the month of May next?

Mr. Dibbs answered,—This matter is now under consideration of the Government.

- (6.) Wynyard Square Reserve:—Mr. Cameron asked the Secretary for Lands,—Is it true that certain persons are allowed a private key to the Wynyard Square Reserve; and have any applications for a similar privilege been received from other persons and refused?
 - Mr. Farnell answered,-I am unable to reply to the questions from official knowledge, as the Reserve is vested in Trustees. I am aware, however, that keys have been allowed to some persons, and that the privilege was withdrawn. I think it probable that other persons have applied for keys, and that the applications have been refused. I will inquire into the matter, and inform my Honorable Friend as to the result.
- (7.) Permanent Artillery Force :- Mr. Cameron asked the Colonial Secretary,- How many members of the Permanent Artillery Force have been imprisoned in Darlinghurst Gaol during the last twelve months; for what offences, and for what terms of imprisonment?
 - Mr. Dibbs answered, The following information has been supplied by the Commandant :- " Eleven, viz., one, disobedience of orders, 168 days imprisonment; three, theft, one 168 days, the other two "120 days imprisonment each; two, insubordination, one 184 days, the other 234 days imprison-"ment; one, striking superior officer, 112 days imprisonment; four, desertion, one 196 days, one "238 days, one six calendar months, and one eight calendar months and fourteen days."

(8.) Incorporation of South Singleton :-- Mr. Levien asked the Colonial Secretary,-

(1.) Did he receive a Petition protesting against the incorporation of South Singleton; if so, how many persons signed the said Petition?

(2.) Did he receive a Petition in favour of the incorporation of South Singleton, and how many persons signed the same; if so, has he come to any determination upon the subject; and if so, upon what grounds?

Annual Vote in lieu of Tolls:—Mr. Gibbes asked the Secretary for Public Works,—Will he say why from the Estimates for 1885 has been omitted the usual Annual Vote:—"Amount in lieu of Toll's for repair of undermentioned Roads: -Sydney via the Dam at Cook's River to Halfway House,-Rocky Point Road to Road from Tom Ugly's Point to Burwood Railway Station, Stanmore Road from Enmore Road to the Canterbury Trust Road, Newtown Railway Bridge to the Undercliff Bridge-£5,000?" Mr.

- Mr. Dibbs answered,—This amount has been voted on Estimates for 1885, as follows:—Main Roads—Rocky Point Road to Road from Tom Ugly's Point to Burwood Railway Station, £2,000; Roads in Municipalities—Sydney and Cook's River Road, £3,000.
- (11.) Railway Sub-way near Newtown Station:—Mr. Gibbes asked the Secretary for Public Works,—When is the Sub-way for foot passengers under the Southern and Western Railway, just to the west of the Newtown Station, to be commenced, and when will it be completed?
 - Mr. Dibbs answered,—The question of making this Sub-way is under consideration.
- (12.) Railway Sub-way near Macdonald Town:—Mr. Gibbes asked the Secretary for Public Works,— (1.) When will be commenced the construction of the promised Sub-way for vehicles at the intersection of the Southern and Western Railway with the extension of Burren-street, Macdonald Town, to Wilson-street, Newtown?

(2.) When is the abovementioned Sub-way likely to be open for traffic?

Mr. Dibbs answered,—

- (1.) The work will be commenced directly the plans are completed; they will be ready in three weeks.
- (2.) As the girders will have to be obtained from England, it will be nine months before the Subway can be opened for traffic.

- (15.) Compensation to John Wilkinson:—Mr. Gouldasked the Secretary for Lands,—Has a decision been yet arrived at in reference to the application of John Wilkinson, of Goorangoola, made 12th September, 1883, for compensation for removal of fence on boundary of his conditional purchase, parish Goorangoola, district Patrick's Plains, caused by original erroneous survey, which application was on 11th January, 1884, said to be in the Survey Department for the purpose of being dealt with; if not, will he cause steps to be taken to have same immediately attended to?
- Mr. Farnell answered,—No decision has yet been arrived at in the matter, which depends upon the result of the investigation of a presumed error in early surveys, which is being carried out through the Survey Department. Attention has been directed to the case.
- (16.) Colonial Tariffs:—Mr. See, for Mr. Targett, asked the Colonial Secretary,—Whether the Government will invite the neighbouring Colonial Governments to form a Conference to consider the advisableness of assimilating the various Colonial Tariffs, with a view to Federation?
 - Mr. Dibbs answered,—The Government do not contemplate any such Conference.
- (17.) Cargo Town Common:—Dr. Ross asked the Secretary for Lands,—Has a Town Common been lately surveyed at Cargo; if so, when will it be dedicated for public purposes?
 - Mr. Farnell answered,-The Survey has not yet been received.
- (18.) Life-boat at Watson's Bay:—Mr. Garrard, for Mr. Abigail, asked the Colonial Treasurer,—
 (1.) Is it true that the Life-boat stationed at Watson's Bay at any time leaked so badly that it became necessary to let her remain at the buoy full of water for days?
 - (2.) Did she ever refuse to right herself when capsized, and was she towed outside the Heads and back again bottom up?

(3.) Is she now fit for use if required?

Mr. Dibbs answered,-

- (1.) When she was first received the boat leaked, in consequence of having been exposed at the Garden Palace, where she was exhibited for a considerable time.
- (2.) She refused to right herself in smooth water in consequence of some of her compartments being out of order and water leaking into them.
- (3.) She is now fit for use, and every confidence is placed in her. She was sent to the Exhibition by Forest Brothers, the builders to the Royal National Life-boat Institution as a model boat.

Proclamation by His Excellency the Right Honorable Lord Augustus William Frederick Spencer Loftus, Knight Grand Cross of the Most Honorable Order of the Bath, a Member of Her Majesty's Most Honorable Privy Council, Governor and Commander-in-Chief of the Colony of New South Wales and its Dependencies.

HEREAS by the Bill passed by the Governor and Legislative Council of New South Wales, in the seventeenth year of the reign of Her Majesty the Queen, intituled "An Act to confer a Constitution on New South Wales and to grant a Civil List to Her Majesty," and assented to by Her Majesty, under the authority of the Act of the Imperial Parliament, passed in the Session of the eighteenth and nineteenth years of the said reign, intituled "An Act to enable Her Majesty to assent to a Bill as amended of the Legislature of New South Wales to confer a Constitution on New South Wales and to grant a Civil List to Her Majesty," it was amongst other things enacted, that it should be lawful for the Governor of New South Wales to prorogue the Legislative Council and Assembly thereof from time to time: And whereas it is expedient to prorogue the said Council and Assembly: Now, therefore, I, Lord Augustus William Frederick Spencer Loftus, the Governor aforesaid, in pursuance of the power and authority so vested in me, do hereby prorogue the said Legislative Council and Assembly, until Wednesday, the seventh day of January, one thousand eight hundred and eighty-five, and the same stand so prorogued accordingly.
