#### WEDNESDAY, 28 MAY, 1941.

1. OPENING OF PARLIAMENT:-The House met at Twelve o'clock at Noon, pursuant to a Proclamation of His Excellency the Governor, bearing date the twenty-first day of May, 1941, of which a copy was read by William Rupert McCourt, Esquire, the Clerk of the Legislative Assembly, as follows:--

"NEW SOUTH WALES, "TO WIT. "(L.S.) "WAKEHURST, "Governor. "New South WALES, "To WIT. "To WIT. "Governor. "By His Excellency the Right Honourable John DE VERE, BARON WAKEHURST, Knight Commander of the Most Distinguished Order of Saint Michael and Saint George, Captain in the Reserve of Officers of the Territorial Army, Governor of the State of New South Wales and its Dependencies, in the Commonwealth of Australia.

"In pursuance of the power and authority vested in me as Governor of the State "of New South Wales by virtue of an Act passed in the second year of the "reign of His late Majesty King Edward the Seventh, being "An Act to "consolidate the Acts relating to the Constitution," I do hereby proclaim that "a Session of the Legislative Council and Legislative Assembly for the State of "New South Wales for the despatch of business shall commence and be holden "on Wednesday, the twenty-eighth day of May, 1941, at 12 o'clock noon, in the "buildings known as the Legislative Council Chambers, in Macquarie-street, in "the City of Sydney; and Members of the said Legislative Council and "Legislative Assembly, respectively, are hereby required to give their attendance "at the said time and place accordingly.

"Given under my Hand and Seal, at Sydney, this twenty-first day of May, "in the year of Our Lord one thousand nine hundred and forty-one, in "the fifth year of His Majesty's Reign.

3. MESSAGE FROM THE COMMISSIONERS :- The Usher of the Black Rod being admitted delivered a Message that, "The Commissioners request the immediate attendance of this Honourable House in the Legislative Council Chamber, to hear the Commission for opening of Parliament read."

The House went, and the Members of both Houses being seated at the request of the Deputy-President, on behalf of the Commissioners,-

#### The Deputy-President said,-

"Honourable Members of the Legislative Council, and Members of the "Legislative Assembly,-His Excellency the Governor, not deeming it fit to be "personally present here this day, has been pleased to cause a Commission to be "issued, under the Public Seal of the State, constituting us Commissioners "to do on behalf of His Majesty, all things necessary to be done in the name "of His Majesty, or in the name of His Excellency the Governor of the State "in and about the opening and holding of this Parliament, to deliver a Message "to the Legislative Assembly, and to do all such other things as may be specially "necessary to enable Parliament to perform acts which admit of no delay, as "will more fully appear by the Commission itself, which must now be read." Whereupon the Commission was read by the Clerk of the Parliaments, as follows:

### "George the Sixth, by the Grace of God, of Great Britain, Ircland, and the "British Dominions beyond the Seas, King, Defender of the Faith, Emperor "of India.

"To all to whom these presents shall come,—"Greeting:

"WHEREAS by Proclamation made on the twenty-first day of May, 1941, His "Excellency, the Right Honourable JOHN DE VERE, BARON WAKEHURST, Knight "Commander of Our Most Distinguished Order of Saint Michael and Saint "George, Captain in the Reserve of Officers of Our Territorial Army, Our "Governor of Our State of New South Wales and its Dependencies, in the "Commonwealth of Australia, did, in pursuance of the power and authority "vested in him as Governor of Our said State. by virtue of an Act passed in the "second year of the reign of His late Majesty King Edward the Seventh, being an "Act to consolidate the Acts relating to the constitution,' proclaim that a Session "of the Legislative Council and Legislative Assembly for the said State should "commence and be holden on Wednesday, the twenty-eighth day of May, 1941, at "the time and place mentioned in the said Proclamation : AND WHEREAS, for certain "causes "Our said Governor cannot conveniently be present in person at the "opening of the said Session of the Legislative Council and Legislative Assembly "of Our said State: Now KNOW YE, that WE, trusting in the discretiou, fidelity "and care of Our trusty and well-beloved the Honourable Sir John Beverley "PEDEN, President of the said Legislative Council, the Honourable ROBERT "REGINALD DOWNING, Minister of Justice and Vice-President of Our Executive "Council of Our said State, and the Honourable ERNEST HENRY FARRAR, "Chairman of Committees, Members of the said Legislative Council, do, with "the advice of Our Executive Council of Our said State, give and grant by the "tenor of these presents unto the said SIR JOHN BEVERLEY PEDEN, ROBERT "REGINALD DOWNING, and ERNEST HENRY FARRAR, or any two of them, full power "in Our name to open and hold the said Session of the said Legislative Council "and Legislative Assembly on the said twenty-eighth day of May or subsequent "day, on Our behalf to do all things necessary to be done in Our Name, or in "the name of Our Governor of Our said State, in and about the opening and "holding of the said Parliament, to deliver Messages to the Legislative Council "and to the Legislative Assembly, and to do all such things as may be specially "necessary to enable Parliament or the said Legislative Council or the said "Legislative Assembly to perform acts which admit of no delay: Commanding "also by the tenor of these presents all whom it concerns to meet in the said "Parliament, that to the said SIR JOHN BEVERLEY PEDEN, ROBERT REGINALD "DOWNING and ERNEST HENRY FARRAR, or any two of them, they diligently "attend in the premises in the form aforesaid.

"In testimony whereof, We have caused these Our Letters to be made "Patent and the Great Seal of Our said State to be hereunto affixed.

"Witness Our Trusty and Well-beloved the Right Honourable JOHN DE "VERE, BARON WAKEHURST, Knight Commander of Our Most "Distinguished Order of Saint Michael and Saint George, Captain in "the Reserve of Officers of Our Territorial Army, Our Governor of "Our State of New South Wales and its Dependencies, in the "Commonwealth of Australia, at Sydney, in Our said State, this "twenty-fourth day of May, in the year of Our Lord one thousand l "nine hundred and forty-one, and in the fifth year of Our Reign.

- 6. ELECTION OF SPEAKER :- Mr. Frank Burke, addressing himself to the Clerk (who, standing up, pointed to him, and then sat down), moved, That Daniel Clyne, Esquire, do take the Chair of this House as Speaker,-which motion was seconded by Mr. Shannon.

And Mr. Clyne, standing in his place, informed the House that he accepted nomination.

Question,-That Daniel Clyne, Esquire, do take the Chair of this House as Speaker,-put by the Clerk and passed.

Whereupon Mr. Frank Burke and Mr. Shannon conducted Mr. Clyne to the Chair, where, standing on the upper step, he returned his acknowledgments to the House for the great honour they had been pleased to confer upon him,-

And thereupon sat down in the Chair.

Mr. McKell, Mr. Mair, Lieut-Colonel Bruxner, Mr. O'Sullivan, Major Shand and Mr. Jackson congratulated Mr. Speaker.

Mr. McKell then informed the House that he had ascertained that His Excellency would receive their Speaker at Government House at Three o'clock, p.m., This Day.

Mr. Speaker left the Chair at Twenty minutes before Two o'clock, p.m., until Ten minutes before Three o'clock, p.m.

Mr. Speaker resumed the Chair at the hour named.

7. MEMBER Sworn :--- The Honourable John Moran Tully, having taken and subscribed the Oath of Allegiance, before the Honourable William John McKell, a Commissioner, and signed the Roll of the House, took his seat as Member for the Electoral District of Goulburn.

8. PRESENTATION OF SPEAKER:-The House then proceeded to Government House to present their Speaker to His Excellency the Governor,-

And having returned,--Mr. Speaker reported that the Assembly had been to Government House, where he informed the Governor that, immediately after the opening of Parliament to-day, the Legislative Assembly, in the exercise of their undoubted right, had proceeded to the election of their Speaker, that the choice had fallen upon him, and that he had now to present himself to His Excellency as their Speaker,--whoreupon His Excellency was pleased to offer him his congratulations. That he had then, in the name and on behalf of the House, laid claim to all their undoubted rights and privileges, particularly to freedom of speech in debate, to free access to His Excellency when occasion should require, and that the most favourable construction should, on all occasions, be put upon their language and proceedings; to all which His Excellency had readily assented.

- Mr. Speaker then expressed his appreciation for the honour the House had been pleased to confer upon him.
- 9. MINISTERIAL STATEMENT-New ADMINISTRATION:-Mr. McKell informed the House that, following upon the resignation of the Honourable Alexander Mair as Premier and a Member of the Executive Council, which action involved the resignation of the whole of his colleagues, His Excellency the Governor had commissioned him to form a Government.

A Bill initialed "An Act to empower the Governor to authorise the execution by or on behalf of the Colonial Treasurer of certain agreements for purposes connected with the ensuring of the provision of emergency stocks of certain goods; to empower the Governor to exempt certain instruments from stamp duty; to amend the Stamp Duties Act, 1920-1940, in certain respects; and for purposes connected therewith,"—as finally passed by the Legislative Council and Assembly, having been presented to the Governor for the Royal Assent, His Excellency has, in the name of His Majesty, assented to the said Bill, and has this day transmitted it to the Legislative Council, to be numbered and forwarded to the proper Officer for enrolment, in the manner required by law.


