Mr Speaker said that most Members would be aware of the greatly increased number of written questions being received in comparison with those of but a few years ago. For example, in the session 1974-75, during which the House met on 57 days 390 questions were asked; in the session 1976-78, of 118 sitting days, 1 319 questions were asked; and in the present session of only 18 sitting days, 521 questions had been asked. There was no justification in thinking that this trend would not continue. With the Questions and Answers Paper averaging between 80 and 90 pages each day it was becoming increasingly difficult and on too many days impossible to have it available by the time the House met. To alleviate some of the difficulties involved, which he need not detail, and in an effort to reduce the quite considerable and ever-increasing costs involved, he had approved of the following procedure being adopted. On the first sitting day of each week the Questions and Answers Paper would contain all questions not answered. Should answers have been received since the previous sitting day the relevant question and answer would also appear on that day. On subsequent sitting days of that week the paper would contain only new questions together with any question previously asked, the answer to which had been received the previous day. In other words, Wednesday's paper would contain only new questions, and answers to questions received on Tuesday. Thursday's paper would contain new questions received on both Tuesday and Wednesday, together with answers received on Wednesday. This change should make it possible to have the Questions and Answers Paper by the time the House met. Other changes might prove to be desirable or necessary. Mr Speaker added that other parliaments receiving large numbers of questions had found it necessary to adopt procedures similar to that which he had approved, 130.

During divisions it would be deemed, therefore, that members occupying those benches would be voting with the Government, whether the Government were voting "aye" or "no". Mr Speaker went on to say that technically, this would be in contradiction of the standing orders which required the "ayes" to be to the right and the "noes" to the left of the Chair respectively. He believed this, however, to be a minor breach when compared with the alternatives. It was his intention that the compromise he had outlined would operate unless experience proved a further change was necessary or until such time as the House otherwise directed, 7. The Speaker stated that the alteration to the seating arrangements since the House rose on Thursday last would be apparent to all members. He did not think that any comment from him was necessary except to say that when a division took place, those members sitting on the centre cross benches would be voting with the Government, 25.
