1. This Act may be cited as the "Ambulance Short title. Transport Service Act, 1919." 2.

(2) If any member of the board absents himself 15 from three consecutive meetings thereof without having obtained leave of absence from the board, his seat shall become vacant.

9. On any vacancy occurring during the term of office Filling of of a member of the board appointed by the Governor, the extraordinary 20 Governor shall appoint a person to such vacant office; and on any vacancy occurring during the term of office of any other member such vacancy shall be filled by a person elected by the ambulance brigade or district committee, as the case may be, which elected the person

25 in whose office the vacancy occurred. The person so appointed or elected shall hold office for the residue of his predecessor's term.

10. The chairman shall have the right to vote on all Voting at occasions, and in the event of an equality of votes shall meetings of board. 30 have a second or casting vote.

One-third of the members of the board shall be a quorum.

11. The board may from time to time appoint or officers and employ such and so many officers and servants as it servants of board. 35 thinks fit and remove or dismiss them.

District committees.

12. The board shall from time to time appoint and Districts. delimit certain districts for the purposes of this Act, and a district committee shall be elected for each district. 40 One of such districts shall be called the Central District, and shall comprise the area within the boundaries from time to time of the Sydney Metropolitan Traffic Area.

13.

13. Each district committee shall be elected annually District in the prescribed manner by contributors to its funds, committees. and be subject to prescribed regulations.

14. The board may, on the recommendation of any Lifemombers. 5 district committee, appoint as life members persons who have rendered meritorious service in aid of the purposes of this Act.

General provisions.

15. The Colonial Treasurer shall out of the Consoli- Endowment 10 dated Revenue Fund pay to the board such sums as of board. Parliament votes for the purposes of this Act.

16. All real and personal property which at the Vesting of commencement of this Act is vested in and held by any property in board. person in trust for or on behalf of any of the ambulance

15 brigades mentioned in section four is hereby transferred to and vested in the board for the purposes of this Act.

17. The board shall report to the Minister in every Report to year as to its proceedings, receipts, and expenditure, and Minister by 20 upon all matters within the scope of its operations under

this Act, and such report shall be laid by him before Parliament.

18. The business and operations of each district for Administhe purposes of this Act shall be administered by the districts. 25 district committee under the control of the board in accordance with regulations made under this Act and in accordance with such by-laws as may be made by such district committee with the approval of the board.

19. Subject to the next succeeding section, the funds Funds of 30 of each district arising from contributions made to such districts. district from subsidies received from the Government in respect of such contributions and from fees and charges received in respect of the operations of the district committee therein shall be administered separately and 35 shall not be used in liquidating, or be liable for, any

claims of or on any other district or district committee.

20. Ten per centum of all such contributions and Contributions subsidies shall be paid to the funds of the board and be to board from applied by the board for the purposes of this Act in 40 such manner as the board may think fit.

Ambulance Transport Service.

21. It shall be unlawful for any committee or Operations in organisation to carry on within the boundaries of any districts without district any operations similar to those carried on by the authority of board or by a district committee under the provisions of board.

5 this Act except with the sanction and under the control of the board: Provided that nothing in this Act shall affect the operations of the St. John Ambulance Association and brigade overseas as carried on prior to the commencement of this Act, other than transport work.

Regulations.

22. (1) The board may, with the approval of the Regulations. Governor, make regulations for carrying out the purposes of this Act, and particularly-

- (a) for the establishment, management, and control of all districts appointed as aforesaid;
- (b) for the election of district committees and for the guidance and control of such committees;
- (c) for elections of members of the board by district committees;
- (d) for voting by post at any election of members of the board or of a district committee;
 - (e) for regulating the meetings of and conduct of business by the board and district committees;
 - (f) for the employment of officers and servants of
 - the board and for payment of salaries and wages:
 - (g) for ensuring discipline and good conduct among such officers and servants;
 - (h) for the use of any property of the board and the rendering of any services by its officers and servants, and for fixing, imposing, and receiving fees and charges in respect of such use and service ;
 - (i) imposing penalties for breach of any regulation made under this Act not exceeding for any offence the sum of five pounds.
 - (2) Such regulations shall-
 - (i) be published in the Gazette;
 - (ii) take effect from the date of publication, or from a later date to be specified in such regulations;

(iii) be laid before both Houses of Parliament within fourteen days after publication if Parliament is in session, and, if not, then within fourteen days after the commencement of the next session. If either House of Parliament passes a resolution at any time within fifteen sitting days after such regulations have been laid before such House disallowing any regulation, such regulation shall therefrom cease to have effect.

Legal procedure.

23. No person shall be entitled to recover against Recovery the board any damages in respect of any injury to against board of damages person or property alleged to have been sustained by for injury. 15 him or any other person by reason of the negligence of the board or any of its officers or servants unless notice in writing that injury has been sustained is

given to the secretary of the board at its office at Sydney within one month, and the action is commenced within 20 six months from the date on which the injury was sustained or in the case of death of the person injured the action is commenced within twelve months from the date of the death.

24. In any action which may be brought against Actions for 25 the board to recover damages or compensation in respect damages or comof personal injury or of injury to property, the court or pensation. jury shall not impose any fine or assess damages or compensation, nor shall judgment be given or entered for the plaintiff for any amount of money exceeding

30 the respective amounts following, that is to say :---

If the personal injury results in death or permanent total disablement, five hundred pounds.

If the personal injury results in temporary disablement, two hundred and fifty pounds.

If the injury be to property only, two hundred and fifty pounds:

Provided that nothing in this Act shall affect any liability of the board under the Workmen's Compensation Act.
