(a) In paragraph (iii) omit the words "or in the Sydney Harbour Trust Commissioners."

- (b) After paragraph (iii) add a new paragraph as follows:—
 - (iv) Such lands vested in the Sydney Harbour Trust Commissioners, and the houses and buildings erected thereon as are not leased or occupied for private purposes and by persons other than the said Commissioners, their officers or servants.
