Amendment of Principal Act.

Discharge of bill of sale.

**2.** (1) The Bills of Sale Act of 1898 is amended by repealing section thirteen thereof and inserting the following section in lieu thereof :—

13. (1) A bill of sale may be discharged, or partly discharged, by a receipt indorsed on the bill of 5 sale, or copy thereof, held by the grantee or person claiming through him, in the form set out in Part I of the Third Schedule hereto, or to the like effect.

(2) If the Prothonotary is satisfied that a bill of sale, or copy, held by the grantee or person 10 claiming through him, for some good reason cannot be produced, such bill of sale may be discharged by a receipt in the form set out in Part II of the Third Schedule hereto.

(3) The signature to any such receipt shall be 15 witnessed by a solicitor of the Supreme Court or by a Justice of the Peace.

(4) The Prothonotary, if required so to do, and if satisfied that the receipt for the money is duly acknowledged, shall register any such discharge by 20 noting the same upon the bill of sale or copy filed.


