## Act No. 40, 1923.

An Act to sanction the construction of works for the amplification of the Katoomba sewerage system; and for purposes connected therewith. [Assented to, 21st December, 1923.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Katoomba Sewer-Short title. age Act, 1923."

### Katoomba Sewerage.

Work sanctioned. 2. The carrying out of the work described in the Schedule is hereby sanctioned, and the Secretary for Public Works is empowered to carry out the said work.

Cost.

3. The cost of carrying out the said work is estimated at eighty-three thousand six hundred pounds (exclusive of land resumptions), and such estimated cost shall not, under any circumstances, be exceeded by more than ten per centum.

The plan.

4. The plan of the works is the plan marked "Katoomba Sewerage Proposed Additional Works," signed by the Secretary for Public Works and countersigned by the Chief Engineer for Water Supply and Sewerage, and deposited in the public office of the said Secretary.

#### SCHEDULE.

The construction of treatment works in Jamieson Valley; a main from the existing West and Central Katoomba main to the treatment works aforesaid, about 6,770 feet in length, and varying from 24 to 12 inches in diameter; a main from the existing effluent main in Leura Park to the before-described main, about 200 feet from the treatment works aforesaid, about 6,060 feet in length, varying from 24 to 12 inches in diameter; a 6 inch pipe sewer about 1,185 feet in length, from an existing sewer in Railway-street, along that street, Vale, and William streets; alterations to existing treatment works; and all works incidental thereto; the whole to be subject to such alterations and modifications as the Minister may deem desirable.
