#### PART I.

Short title and commencement. 1. (1) This Act may be cited as the "Mines Rescue Act, 1924."

(2) This Act shall come into operation on the 10 thirty-first day of December, one thousand nine hundred and twenty-four.

Interpretation. 2. In this Act, unless the context otherwise indicates 20 or requires,—

- "Breathing apparatus" means an apparatus of such a character that the wearer carries with him all the means for respiration in an irrespirable atmosphere, and is of a type for 25 the time being approved by the Minister.
- "Central rescue station" or "rescue station" means a station established under this Act to serve mines within a district.
- "District" means an area declared by proclamation 30 to be a district for the purposes of this Act.
- "Fund" means the Mines Rescue Stations Fund established under this Act.
- "Inspector" means an inspector of collieries appointed under the provisions of the Coal 35 Mines Regulation Act, 1912, or any Act amending the same.

- "Prescribed" means prescribed by this Act or by the regulations.

"Regulations" means regulations made under the authority of this Act.

"Superintendent" means superintendent of a rescue station.

**3.** (1) This Act applies to all mines in which coal or Application of Act. 15 shale is worked.

(2) The Minister may exempt from all or any of No. 347, r. 1. the provisions of this Act any mine in which less than

fifty persons are employed underground, if the mine is so situated or the circumstances are such that the 20 application of all or any of the provisions of this Act are not, in the opinion of the Minister, reasonably

practicable.

4. No person, unless authorised by the manager or Entry to a mine after official appointed by the manager for the purpose, or in explosion.

#### PART II.

#### RESCUE BRIGADES.

5. (1) Subject to the provisions of this Act there Organisation shall be organised and maintained by the owner at maintenance. every mine competent rescue brigades on the following *Ibid.* r. 3.

Where the number of underground employees is more than two hundred and fifty but not more than seven hundred—two brigades.

(2) A group of mines belonging to the same owner, of which all the shafts or exits for the time 10 being in use in working the mines lie within a circle having a radius of two miles shall, for the purpose of ascertaining the number of brigades to be maintained, be treated as one mine.

(3) A rescue brigade shall consist of not less than 15 five persons employed at the mine, selected with regard to their medical fitness, physical qualifications, and knowledge of underground work and first aid.

(4) There shall be selected by the owner from the ranks of each rescue brigade one person or leader 20 who shall act as captain of the brigade and perform the duties prescribed.

(5) A brigade shall not be deemed competent unless—

- (a) the members of the brigade have been given a 25 course of instruction and training approved by the Minister;
- (b) the members have thereafter in every quarter at least one day's practice with breathing apparatus, which practice shall at least twice 30 in the year take place at the mine;
- (c) the members of the brigade shall have received instruction in the reading of mine plans, in the use and construction of breathing apparatus, in the properties and detection of inflammable 35 gases, and in the various appliances used in connection with mine rescue and first aid work.

(6) The members of a rescue brigade who have undergone (to the satisfaction of the Minister) the 40 approved course of training may be granted a certificate or medallion as may be prescribed. (7)

#### Mines Rescue.

(7) The owner shall pay to persons other than instructors for time occupied in performing duties under this section an amount not being less than the rate of a first-class shiftman's wages ruling for the time being 5 at the mine.

(8) Arrangements shall be made by the owner at every mine for summoning members of rescue brigades immediately their services are required.

6. Where it can be proved to the satisfaction of the Failure to 10 Minister that the necessary number of persons employed form a brigade. underground at a mine will not consent to form the Ibid. r. 4. requisite number of brigades, or having offered their services fail to be trained or maintain their training, the owner of the mine shall not be liable to any penalty

- (a) that he has endeavoured to the best of his ability to constitute the requisite number of brigades, and has afforded every opportunity to the persons employed at the mine to undergo the necessary training; and
- (b) that he has made application for the supply of an existing rescue corps from a central rescue station of a district and contributes as if the mine was situated within the district.
- 25 7. (1) There shall be provided by the owner as soon Breathing as reasonably practicable after the passing of this Act apparatus and maintained at every mine five suits of portable provided. breathing apparatus for each brigade required by this
- Act to be maintained at the mine. The apparatus must 30 be capable of enabling the wearer to remain for at least one hour in an irrespirable atmosphere and must be kept ready for immediate use, and it shall be kept in suitable receptacles and housed in a dry room provided for the purposes of this Act.
- (2) There shall be provided by the owner, and 35 maintained at every mine at which a rescue brigade is established under this Part, such other accessories, appliances, and requisites as may be prescribed as being necessary for the carrying out of rescue operations.

#### PART III.

#### CENTRAL RESCUE STATIONS.

Districts and rescue ations.

8. (1) The Governor may by proclamation published in the Gazette establish districts for the purpose of this Act and may from time to time by proclamation vary 5 the boundaries of such districts.

(2) The Governor may establish in any district a central rescue station.

(3) Any buildings considered necessary may be erected out of funds to be voted by Parliament subject 10 to repayment out of the fund.

Contribution to rescue stations by owners.

9. The owner of every mine within a district shall contribute towards the cost of erection, equipment, and maintenance of the rescue station such sum as may be prescribed, based upon every ton of coal or shale 15 won from the mine during the preceding year ending the thirty-first day of December, but such sum shall not exceed one penny per ton. The first payment shall be made on or before the twenty-first day of January, one thousand nine hundred and twenty-five, and thereafter 20 within the first twenty-one days of January in each year.

How contribe applied.

**10**. (1) All moneys received as contributions from butions are to the owner shall be paid as prescribed into an account to be opened in the Treasury to be known as the Mines 25 Rescue Stations Fund, which fund shall be under the direction and control of the Minister, and shall, subject to this Act, be applied by him for the purpose of the administration and execution of this Act and for no 30 other purpose whatsoever.

(2) The fund shall be applied towards—

- (a) the cost of maintenance, upkeep, and administrative expenses of the rescue station within a district;
- (b) the salary of the superintendent;
- (c) the wages of persons employed as instructors, or as members of or acting with the corps attached to the station; and

11. Out of the fund there shall be kept and main-Rescue tained at the central rescue station of a district not less apparatus. than fifteen complete suits of breathing apparatus
10 together with such accessories, appliances, and other requisites as the Minister may direct as being necessary for the carrying out of rescue operations. A motor car shall also be provided and maintained thereat and kept in constant readiness for use.

15 12. (1) Every central rescue station shall be under Superinthe immediate control of a superintendent, to be appointed by the Governor upon the recommendation of the Public Service Board.

(2) No person shall be appointed superintendent 20 unless he has had at least five years actual practical experience in coal mines, and can furnish satisfactory evidence that he has a thorough knowledge—

- (a) of the construction and use of breathing apparatus;
- (b) of the methods of working and ventilating mines;
  - (c) of the nature and properties of noxious and poisonous gases;

(d) of the means of detecting the presence of and preventing accumulations of such gases and the means of removing same; and

(e) of the uses and dangers of electricity as applied to mines.

(3) The superintendent shall devote his whole 35 time to the duties of his office, and shall perform all such duties in the instruction of rescue brigades and the maintenance and working of the station as may be prescribed.

(4)

(4) Whenever the superintendent of a central rescue station shall receive notification that an explosion or accident has occurred at a mine within the district he shall—

- (a) proceed immediately with suitable equipment 5 to the mine; and
- (b) on arrival co-operate with the management of the mine in rescue work; and
- (c) superintend the work of the rescue corps or rescue brigades in saving life and property. 10

#### PART IV.

#### ESTABLISHMENT OF PERMANENT RESCUE CORPS.

Permanent corps at central rescue stations.

13

**13.** (1) The Minister may in any district establish at a central rescue station a permanent corps, subject to the following conditions, and on such establishment 15 the mines within the district shall become exempt from the provisions of Part II of this Act :---

- (a) The rescue corps at such central rescue station shall consist of such number of men (not less than six) as the Minister may approve. 20
- (b) The members of the corps shall be appointed by the Minister upon the recommendation of the superintendent, and their employment may be terminated by the Minister on the like recommendation. 25
- (c) Each member of such corps shall be carefully selected by the superintendent on the ground of his physical fitness and general suitability for the work, and shall hold a certificate of proficiency in first aid from a society or body 30 approved by the Minister.
- (d) It shall be a condition of the employment of a member of the corps that he shall at all times be within immediate call of the station.
- (e) Each member of the corps shall be thoroughly 35 trained in the use of breathing apparatus and in rescue work in accordance with a scheme approved by the Minister. (2)

(2) One or more competent persons from each mine within a district shall be selected by the owner for the purpose of acting with the rescue corps when summoned, as follows :---

- If the total number of underground employees is not less than fifty or more than two hundred and fifty-not less than one person.
  - If the total number of underground employees is more than two hundred and fifty but not
    - more than seven hundred—not less than three persons.
  - If the total number of underground employees is more than seven hundred-not less than five persons.
- 15 Such persons shall out of the fund be paid such fees as may be prescribed, and shall attend for training with the rescue corps when required by the superintendent, and the owner shall make arrangements for summoning such persons immediately their services are needed.

20 (3) No breach of subsection two of this section shall be deemed to have been committed in consequence of failure to maintain at the mine the full number of trained men in accordance with the foregoing provisions if the owner of the mine satisfies the Minister that he

25 has made every effort to comply with those provisions and that the failure is due to causes over which he had no control.

(4) There shall be provided and maintained by the owner at the mine two complete suits of breathing 30 apparatus, together with such accessories, appliances, and other requisites as may be prescribed or as the Minister may direct as being necessary for the carrying out of rescue operations.

(5) Telephone communication shall be estab-35 lished by the owner of the mine between the mine and the rescue station.

**15.** (1) There shall be appointed by the Minister, upon the recommendation of the superintendent, at every rescue station, in addition to the superintendent, 5 persons who are competent to train a rescue corps or rescue brigade, and the number so appointed shall in no case be less than the number specified in the following scale :---

- (a) At rescue stations maintaining a permanent 10 rescue corps—if the total number of persons employed underground at the mines in the district served by the stations does not exceed fifteen thousand, one in addition to the superintendent; if the number exceeds fifteen 15 thousand, two in addition to the superintendent.
- (b) At rescue stations not maintaining a permanent rescue corps—if the total number of brigades required to be provided at the mines served by ... the station does not exceed fifty, one in addition 20 to the superintendent; exceeding fifty, two in addition to the superintendent.

(2) The owner of a mine at which a rescue brigade is organised shall, subject to the approval of the superintendent, be entitled to engage the services of 25 any such instructor to train the members of the rescue brigade upon payment of the prescribed rates.

(3) The instructor shall, subject to the direction of the superintendent, perform such duties as may be prescribed. 30

**16.** The remuneration of the persons employed under this Part shall be paid out of the fund and shall be as prescribed.

**17.** (1) The erection of central rescue stations as provided by this Act is hereby authorised; and the 35 Secretary for Public Works is hereby authorised to undertake and carry out the said works subject to the provisions of this Act, and for that purpose shall be, and shall have the powers and duties of, a Constructing Authority within the meaning of the Public Works Act, 40 **1912.** (2)

(2) If any site required for the erection of a central rescue station is situate within the boundaries of a lease of Crown lands held under the provisions of the Mining Act, 1906, the resumption thereof shall be 5 deemed to be for a public purpose within the meaning of section one hundred and thirty of the Mining Act,

18. There shall be kept by the owner at every mine Plans. tracings of the workings of the mine up to a date not S.R.O., 1912 10 more than three months previously, showing the ven-

tilation and all principal doors, stoppings, and air crossings, regulators, and telephone stations, and distinguishing the intake air by a different colour from return air, which tracings shall be in a suitable form

15 for use by the brigades or rescue corps. The signs and distinguishing features used on the tracings shall be as prescribed.

19. At every mine there shall be established as Uniform rules and prescribedsignals.

- (a) a code of rules for the conduct and guidance Ibid. r. 8. of persons employed in rescue operations;
  - (b) a code of signals to be used in such rescue operations.

The codes shall be conspicuously displayed at the mine 25 and all brigades shall be thoroughly instructed therein.

**20.** At every mine to which this Act applies there Room for shall be a room provided and maintained by the owner rescue and exclusively for rescue and first aid purposes. The purposes. room-

(a) shall be situated on the surface conveniently near the entrance of the mine and shall be distinguished by a large red cross on the door;

(b) shall have a floor space of not less than one hundred square feet, and shall be provided with ample means of natural and artificial lighting and heating, with a strong table and sufficient lockers, drawers, and shelves for articles required to be provided by this Act, and with a plentiful supply of drinking water and water for washing; and

(c) shall be placed under the charge of a person appointed in writing by the manager, who shall hold a certificate of proficiency in first aid from a society or body approved by the Minister, and shall also always be readily 5 available during working hours and shall be responsible for maintaining the room and the fittings and appliances thereof in good order and for attending to the needs and comfort of the injured and of any rescue team or rescue 10 brigade engaged in practices or work at the mine.

Powers of inspectors.

21. (1) An inspector shall have power to make such examination and inquiry as may be necessary to ascertain whether the provisions of this Act are 15 complied with.

(2) Any person who wilfully obstructs any inspector in the execution of his duty under this Act, and every owner who refuses or neglects to furnish to the inspector the means necessary for making any 20 inspection, examination, or inquiry under this Act, shall be guilty of an offence against this Act.

(3) Every inspector shall make an annual report of the result of his inspections during the 25 preceding year to the Minister.

**22.** If the inspector considers that the owner has failed to comply with any of the requirements of this Act or that any appliance, apparatus, material, or thing is defective, he shall give notice to the owner requiring that same be forthwith remedied, and unless the 30 same be remedied within the period named in the notice the owner shall be deemed guilty of an offence

23. Any order or notice required by this Act or the regulations to be served upon the owner may be served 35 personally or by post addressed to the manager at the mine.

24. Any person who by act or omission contravenes any of the provisions of this Act shall be liable on summary conviction to a penalty not exceeding fifty 10 pounds.

Penalties.

#### Mines Rescue.

25. (1) The Governor may make regulations not Regulations. inconsistent with this Act prescribing all matters which by this Act are required or permitted to be prescribed, or which are necessary or convenient to be prescribed 5 for giving effect to this Act, and any such regulation may prescribe-

- (a) a penalty for any breach thereof, and also distinct penalties in case of successive breaches thereof, provided that no such penalty shall exceed fifty pounds;
- (b) a daily or weekly penalty, not exceeding two pounds a day or five pounds a week, for any continuing breach thereof.

(2) The regulations shall be published in the 15 Gazette, and shall take effect from the date of publication or from a later date to be specified in the regulations.

(3) The regulations shall be laid before both Houses of Parliament within fourteen sitting days after publication if Parliament is then in session, and if not, 20 then within fourteen sitting days after the commencement of the next session.

(4) If either House of Parliament passes a resolution of which notice has been given at any time within fifteen sitting days after the regulations have



The owner of every mine within a district shall contribute towards the cost of erection, equipment, and maintenance of the rescue station such sum as may be prescribed, based upon every ton of coal or shale 20 won from the mine during the preceding year ending the thirty-first day of December, but such sum shall not exceed one penny per ton. The first payment shall be made on or before the twenty-first day of January, one thousand nine hundred and twenty-five, and thereafter 25 within the first twenty-one days of January in each year.

How contributions are to be applied.

10. (1) All moneys received as contributions from the owner shall be paid as prescribed into an account to be opened in the Treasury to be known as the Mines 30 Rescue Stations Fund, which fund shall be under the direction and control of the Minister, and shall, subject to this Act, be applied by him for the purpose of the administration and execution of this Act and for no other purpose whatsoever. 35

(2) The fund shall be applied towards—

- (a) the cost of maintenance, upkeep, and administrative expenses of the rescue station within a district;
- (b) the salary of the superintendent;
- (c) the wages of persons employed as instructors, or as members of or acting with the corps attached to the station; and

> (d) the instalments necessary to create a sinking fund for the extinguishment within a period of ten years of the liability for the capital cost of the station together with interest on the amount of such liability at a rate not exceeding six per centum per annum.

11. Out of the fund there shall be kept and main-Rescue 15 tained at the central rescue station of a district not less apparatus than fifteen complete suits of breathing apparatus together with such accessories, appliances, and other requisites as the Minister may direct as being necessary

20 for the carrying out of rescue operations. A motor car shall also be provided and maintained thereat and kept in constant readiness for use.

**12.** (1) Every central rescue station shall be under Superinthe immediate control of a superintendent, to be tendent. 25 appointed by the Governor upon the recommendation of the Public Service Board.

(2) No person shall be appointed superintendent unless he has had at least five years actual practical experience in coal mines, and can furnish satisfactory 30 evidence that he has a thorough knowledge—

- (a) of the construction and use of breathing apparatus;
- (b) of the methods of working and ventilating mines;

- (c) of the nature and properties of noxious and poisonous gases;
- (d) of the means of detecting the presence of and preventing accumulations of such gases and the means of removing same; and
- (e) of the uses and dangers of electricity as applied to mines.

(3) The superintendent shall devote his whole time to the duties of his office, and shall perform all such duties in the instruction of rescue brigades and the maintenance and working of the station as may be prescribed.

(4) Whenever the superintendent of a central rescue station shall receive notification that an explosion or accident has occurred at a mine within the district he shall-

- (a) proceed immediately with suitable equipment 10 to the mine; and
- (b) on arrival co-operate with the management of the mine in rescue work; and
- (c) superintend the work of the rescue corps or rescue brigades in saving life and property. 15

#### PART IV.

#### ESTABLISHMENT OF PERMANENT RESCUE CORPS.

Permanent corps at stations.

**13.** (1) The Minister may in any district establish central rescue at a central rescue station a permanent corps, subject to the following conditions, and on such establishment 20 the mines within the district shall become exempt from the provisions of Part II of this Act :---

> (a) The rescue corps at such central rescue station shall consist of such number of men (not less than six) as the Minister may approve.

- (b) The members of the corps shall be appointed by the Minister upon the recommendation of the superintendent, and their employment may be terminated by the Minister on the like recommendation. 30
- (c) Each member of such corps shall be carefully selected by the superintendent on the ground of his physical fitness and general suitability for the work, and shall hold a certificate of proficiency in first aid from a society or body 35 approved by the Minister.

(d)

- (d) It shall be a condition of the employment of a member of the corps that he shall at all times be within immediate call of the station.
- (e) Each member of the corps shall be thoroughly trained in the use of breathing apparatus and in rescue work in accordance with a scheme approved by the Minister.

(2) One or more competent persons from each mine within a district shall be selected by the owner
10 for the purpose of acting with the rescue corps when summoned, as follows:—

- If the total number of underground employees is not less than fifty or more than two hundred and fifty—not less than one person.
- If the total number of underground employees is more than two hundred and fifty but not more than seven hundred—not less than three persons.
  - If the total number of underground employees is more than seven hundred—not less than five persons.

Such persons shall out of the fund be paid such fees as may be prescribed, and shall attend for training with the rescue corps when required by the superintendent, 25 and the owner shall make arrangements for summoning such persons immediately their services are needed.

(3) No breach of subsection two of this section shall be deemed to have been committed in consequence of failure to maintain at the mine the full number of

- 30 trained men in accordance with the foregoing provisions if the owner of the mine satisfies the Minister that he has made every effort to comply with those provisions and that the failure is due to causes over which he had no control.
- 35 (4) There shall be provided and maintained by the owner at the mine two complete suits of breathing apparatus, together with such accessories, appliances, and other requisites as may be prescribed or as the Minister may direct as being necessary for the carrying 40 out of rescue operations.

**14.** Every rescue corps shall, after the completion rescue corps. of its training, undergo at least six practices under- 5 ground in mines with breathing apparatus every year. and at least one such practice in every quarter.

#### PART V.

#### GENERAL.

Instructors.

15. (1) There shall be appointed by the Minister, 10 upon the recommendation of the superintendent, at every rescue station, in addition to the superintendent, persons who are competent to train a rescue corps or rescue brigade, and the number so appointed shall in no case be less than the number specified in the following 15 scale :-

- (a) At rescue stations maintaining a permanent rescue corps-if the total number of persons employed underground at the mines in the district served by the stations does not exceed 20 fifteen thousand, one in addition to the superintendent; if the number exceeds fifteen thousand, two in addition to the superintendent.
- (b) At rescue stations not maintaining a permanent rescue corps—if the total number of brigades 25 required to be provided at the mines served by the station does not exceed fifty, one in addition to the superintendent; exceeding fifty, two in addition to the superintendent.

(2) The owner of a mine at which a rescue 30 brigade is organised shall, subject to the approval of the superintendent, be entitled to engage the services of any such instructor to train the members of the rescue brigade upon payment of the prescribed rates.

(3) The instructor shall, subject to the direction 35 of the superintendent, perform such duties as may be prescribed. 16.

16. The remuneration of the persons employed Remuneraunder this Part shall be paid out of the fund and tion of shall be as prescribed.

17. (1) The erection of central rescue stations as Acquisition 5 provided by this Act is hereby authorised; and the of site and erection of Secretary for Public Works is hereby authorised to buildings. undertake and carry out the said works subject to the provisions of this Act, and for that purpose shall be, and shall have the powers and duties of, a Constructing

10 Authority within the meaning of the Public Works Act, 1912.

(2) If any site required for the erection of a central rescue station is situate within the boundaries of a lease of Crown lands held under the provisions of the

15 Mining Act, 1906, the resumption thereof shall be deemed to be for a public purpose within the meaning of section one hundred and thirty of the Mining Act, 1906.

**18.** There shall be kept by the owner at every mine Plans. tracings of the workings of the mine up to a date not S.R.O., 1912 more than three months previously showing the year No. 347, r. 4

20 more than three months previously, showing the ventilation and all principal doors, stoppings, and air crossings, regulators, and telephone stations, and distinguishing the intake air by a different colour from return air, which tracings shall be in a suitable form

25 for use by the brigades or rescue corps. The signs and distinguishing features used on the tracings shall be as prescribed.

**19.** At every mine there shall be established as Uniform prescribedsignals.

- (a) a code of rules for the conduct and guidance *Ibid. r. 8.* of persons employed in rescue operations;
  - (b) a code of signals to be used in such rescue operations.

The codes shall be conspicuously displayed at the mine 35 and all brigades shall be thoroughly instructed therein.

20. At every mine to which this Act applies there Room for shall be a room provided and maintained by the owner first aid exclusively for rescue and first aid purposes. The purposes. room-

(a) shall be situated on the surface conveniently near the entrance of the mine and shall be distinguished by a conspicuous sign on the door; (b)

(b) shall have a floor space of not less than one hundred square feet, and shall be provided with ample means of natural and artificial lighting and heating, with a strong table and sufficient lockers, drawers, and shelves for articles 5 required to be provided by this Act, and with a plentiful supply of drinking water and water for washing; and

(c) shall be placed under the charge of a person appointed in writing by the manager, who 10 shall hold a certificate of proficiency in first aid from a society or body approved by the Minister, and shall also always be readily available during working hours and shall be responsible for maintaining the room and the 15 fittings and appliances thereof in good order and for attending to the needs and comfort of the injured and of any rescue team or rescue brigade engaged in practices or work at the mine.

If the inspector considers that the owner has failed to comply with any of the requirements of this 35 Act or that any appliance, apparatus, material, or thing is defective, he shall give notice to the owner requiring that same be forthwith remedied, and unless the same be remedied within the period named in the notice the owner shall be deemed guilty of an offence 40 against this Act.

25. (1) The Governor may make regulations not Regulations.
10 inconsistent with this Act prescribing all matters which by this Act are required or permitted to be prescribed, or which are necessary or convenient to be prescribed for giving effect to this Act, and any such regulation may prescribe—
15 (a) a penalty for any breach thereof and also

- (a) a penalty for any breach thereof, and also distinct penalties in case of successive breaches thereof, provided that no such penalty shall exceed *fifty* pounds;
- (b) a daily or weekly penalty, not exceeding *two* pounds a day or *five* pounds a week, for any continuing breach thereof.

(2) The regulations shall be published in the Gazette, and shall take effect from the date of publication or from a later date to be specified in the regulations.

25 (3) The regulations shall be laid before both Houses of Parliament within fourteen sitting days after publication if Parliament is then in session, and if not, then within fourteen sitting days after the commencement of the next session.

30 (4) If either House of Parliament passes a resolution of which notice has been given at any time within fifteen sitting days after the regulations have been laid before such House disallowing any regulation or part thereof, the regulation or part shall thereupon 35 cease to have effect.
