Act No. 33, 1924.

An Act to vest certain land held upon trust for the Narrabri Hospital in His Majesty ; to enable the trustees of the Narrabri Pastoral, Agricultural, and Horticultural Association to transfer certain land to the trustees of the Narrabri Hospital ; and for purposes connected therewith. [Assented to, 9th December, 1924.]

**B**E it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

**2.** The lands described in the First Schedule to this Act, being part of the land comprised in certificate of title, registered volume one thousand two hundred and twenty-four, folio thirty, held by trustees for the Narrabri Hospital, are hereby vested in His Majesty, and shall be deemed to be Crown land reserved from sale or lease within the meaning of the Crown Lands Consolidation Act, 1913.

## Act No. 33, 1924.

## Narrabri Hospital Site Bill, 1924.

---

### EXPLANATORY NOTE.

THE object of the Bill is to enable the carrying out of a certain arrangement whereby in exchange for an area of little more than a quarter of an acre the trustees of the Narrabri Hospital will obtain a block of 6 acres 2 roods 27 perches now vested in the trustees of the Narrabri Pastoral, Agricultural, and Horticultural Association, which block adjoins the present hospital site. The last-named Association, in exchange for the transfer of the land in the Second Schedule, will by appropriate action under the Crown Lands Consolidation Act, 1913, have added to the area now vested in it a block of about 20 acres now included in a travelling stock route and an unnecessary road to the north-east of its present holding. It is also proposed by similar action to add the area divested from the Hospital to the adjoining area dedicated for a racecourse and show-ground. Owing to the state of the registered titles of the trustees of the Narrabri Pastoral, Agricultural, and Horticultural Association it is not competent for the trustees to make the necessary transfer to complete the arrangement without the authority of the Legislature.

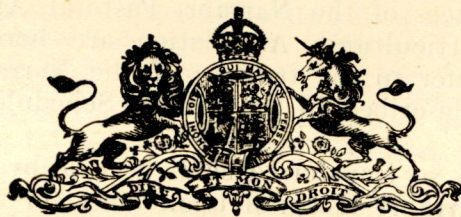
