Public Works (Amendment)

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :—

Short title.

1. This Act may be cited as the "Public Works (Amendment) Act, 1922."

2. The Public Works Act, 1912, is amended as follows :—

(1) By omitting from subsection one of section seven the words "the first session of";

(2) by omitting subsection one of section nine and inserting the following new subsection :—

(1) Upon a resolution being passed by the Assembly that the Parliamentary Standing Committee on Public Works be appointed, of the passage of which the Legislative Council shall be informed by Message asking its concurrence, the Speaker shall fix a date, being within a period of fourteen days from the passing of the resolution, up to and including which he shall receive nominations of members of the Legislative Assembly for election and appointment as members of the committee;

(3) (a) by inserting in section ten after the word "nine" the words "other than the provisions for passing a resolution that the committee be appointed";

(b) by adding at the end of the same section the following words :—"The date to be fixed by the President for the election shall be within a period of fourteen days from the date of the concurrence of the Legislative Council with the resolution of the Assembly."

3. The provisions of the Public Works Act, 1912, as amended by this Act shall govern the election of the Parliamentary Standing Committee on Public Works for the present (the twenty-sixth) Parliament as well as the election of such committees in future Parliaments.

Public Works (Amendment) Bill.

EXPLANATORY NOTE.

THE Public Works Act, 1912, requires the Public Works Committee to be elected during the first session of each Parliament.

During the first session of the present Parliament, and on a previous occasion, time did not allow of the election taking place during the first session.
