Act No. 50, 1923.

An Act to sanction the construction of additional works of water supply for the City of Sydney and adjoining districts; and for purposes connected therewith. [Assented to, 21st December, 1923.]

BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

1. This Act may be cited as the "Sydney Water Short title.
Supply Amplification Act, 1923." **2.**

2. The carrying out of the works described in the Schedules to this Act is hereby sanctioned, and the Secretary for Public Works is empowered to carry out the said works. The said works shall be deemed to be authorised works within the meaning of the Public Works Act, 1912.

Cost.

3. The cost of carrying out the said works set out in the First and Second Schedules, exclusive of land resumptions, is estimated at eight hundred and twenty-five thousand seven hundred and thirty pounds and four hundred and twenty-five thousand pounds respectively, and such estimated costs shall not, under any circumstances, be exceeded by more than ten per centum.

4. (1) The plan of the works set out in the First Schedule is the plan marked "Sydney Water Supply—Showing Proposed Dam on Nepean River (Lupton)" signed by the Secretary for Public Works and countersigned by the Chief Engineer for Water Supply and Sewerage, and deposited in the public office of the said Secretary.

(2) The plan of the works set out in the Second Schedule is the plan marked "Proposed 48-in. Main from Pipe Head Basin to Ryde Pumping Station," signed by the Secretary for Public Works and countersigned by the Chief Engineer for Water Supply and Sewerage, and deposited in the public office of the said Secretary.

5. On the completion of the said works or any of them the Governor shall forthwith notify the same in the Gazette, and upon such notification the works described in such notification shall be vested in the Board of Water Supply and Sewerage under the provisions of and for the purposes of the Metropolitan Water and Sewerage Acts, 1880–1922.

SCHEDULES.

FIRST SCHEDULE.

1. Construction of concrete and masonry dam to impound 11,600 million gallons of water more or less on the Nepean River, at Lupton, at a point a short distance above the crossing of the road from West Bargo Railway Station to the Avon Dam, with outlet works, spillway, and works pertaining thereto.
 2. Lines for transmission of electric current for power, telephone, or signalling purposes.
 3. Railways, ropeways, roads, and other means of access for conveyance of plant and materials, with authority to obtain temporary possession of routes of same and crossing of roads and Crown lands.
 4. Construction of siding from Main Southern Railway for carriage of plant and materials.
 5. Acquisition of land for quarrying purposes and the working of quarries thereon.
 6. Clearing the area to be inundated by the storage waters.
 7. Works connected with the preceding.
- The whole to be subject to such deviations or modifications as may be deemed desirable by the Constructing Authority.

SECOND SCHEDULE.

A water main 48 inches in diameter from Pipe Head to Ryde Pumping Station, as shown on the Plan referred to in subsection two of section four of this Act, together with all necessary subsidiary works; the whole to be subject to such deviations or modifications as may be deemed desirable by the Constructing Authority.

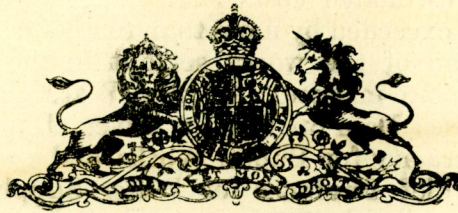
