Wellington Cattle Sale-yards Disposal Bill, 1924.

EXPLANATORY NOTE.

THE object of this Bill is to remove any possible legal difficulty in the way of the land in the old market site at Wellington, which is no longer required for that purpose, being disposed of under the Returned Soldiers Settlement Act, 1916, or failing disposal under that Act, under the Crown Lands Consolidation Act, 1913.

The land is suitable for residential sites, and has already been subdivided into ten allotments of about 38 perches each.

The Wellington Cattle Sale-yards Act of 1904 (a private Act), repealed by the Schedule of the Local Government Act, 1906, gave the local Council certain rights in respect of this land. The Council is agreeable to the land being made available as dwelling sites for returned soldiers.
