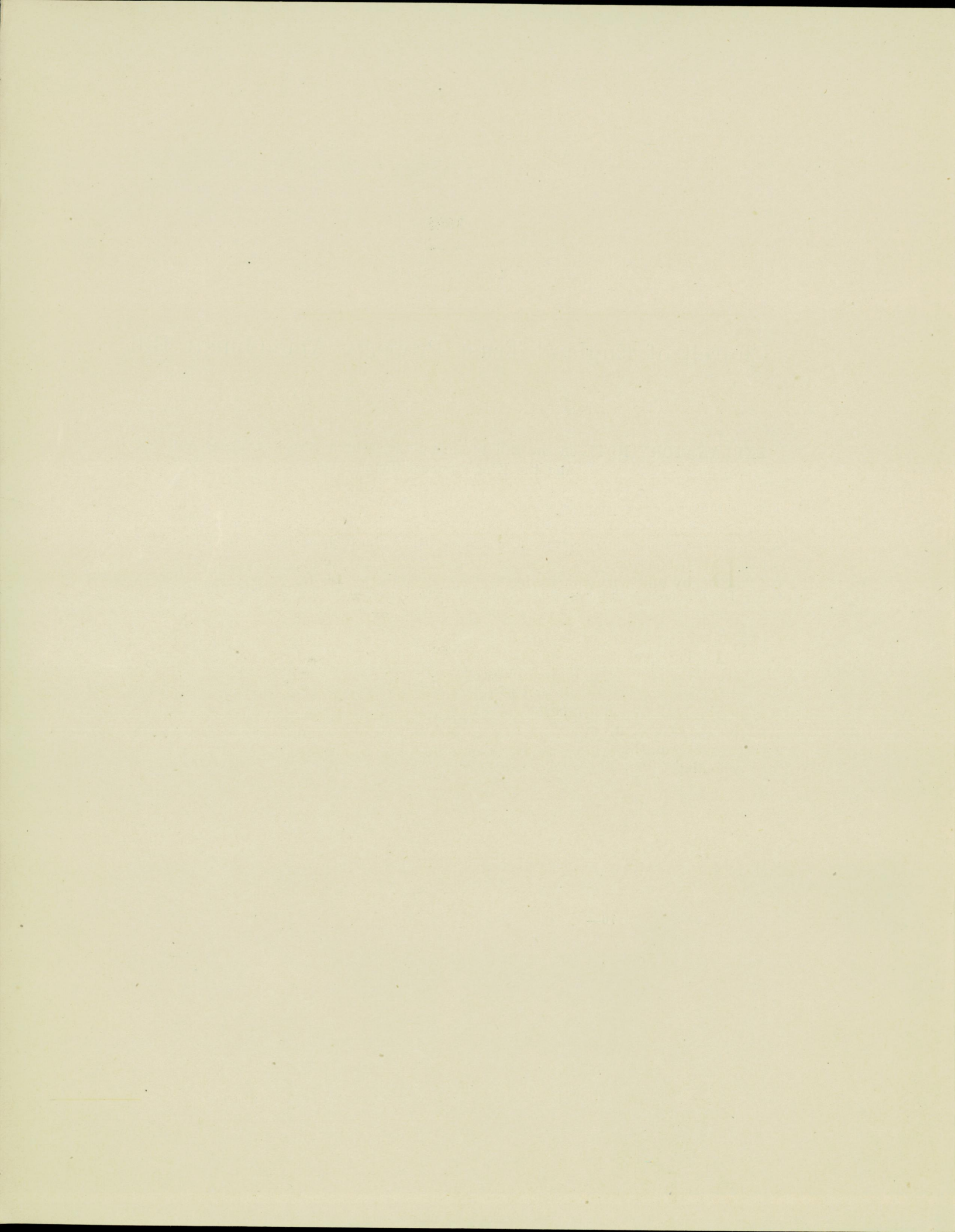

Church of England Trust Property Amendment Bill.

EXPLANATORY NOTE on the Bill to amend the Church Property Trust Act, 1917,
and the King's School Council Act.

THIS measure proposes to repeal certain sections of the abovementioned Acts. The effect will be that the King's School will come under the control of the Synod of the Church of England, and also that there shall be representation of the Old Boys' Union of the King's School upon the Governing Council of the School.

The Bill meets with the approval of the Old Boys' Union, to which it has been submitted.
