Act No. 44, 1924.

An Act to provide for the re-vesting of certain land in the Parish of Manly Cove, resumed under the Public Works Act, 1912, for the purpose of protecting the purity of the Manly Water Supply: and for purposes connected therewith. [Assented to, 20th December, 1924.]

WHEREAS by a notification of resumption under Preamble. and in pursuance of the Public Works Act, 1912, published in the Gazette of the first day of December, one thousand nine hundred and twenty-two, the land described in the said notification of resumption (whereof the land described in the Schedule to this Act forms

forms part) was resumed for a certain public purpose, namely, the protection of the purity of the water supply at Manly: And whereas it has been found that the said land, described in the Schedule to this Act, is not required for the said purpose, and it is desired to revest the same in the persons who were entitled thereto at the time of the said resumption: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Manly Water Supply (Panorama Estate Revesting) Act, 1924."

Revesting of land described in First Schedule.

2. On the passing of this Act the land described in the First Schedule to this Act shall revest in the persons who were entitled thereto at the time of such resumption as aforesaid and for such estates and interests and with and subject to such rights as were subsisting in respect of the said land at the time of such resumption, and such land shall be subject to all trusts, obligations, estates, interests, contracts, charges, rates, rights-of-way or other easements from which it was freed and discharged by such resumption as if the said land had not been resumed, and shall also be subject to any interests in or equities binding on the compensation moneys created since the said resumption.

Dedication of roads.

3. The lands comprised within the Second Schedule to this Act which are shown as public roads on a plan deposited in the office of the Registrar-General and numbered twelve thousand three hundred and fifteen are hereby dedicated as public roads.

Saving of rights under a certain agreement.

4. Nothing in this Act shall affect the rights of the Minister for Public Works or His Majesty or the Government of the State of New South Wales under a certain agreement bearing date the thirty-first day of March, one thousand nine hundred and twenty-four, made between Albert Edwin Dalwood of the first part Ernest Francis Hartley Brown of the second part the Minister for Public Works of the third part and His Most Gracious Majesty King George V of the fourth part.

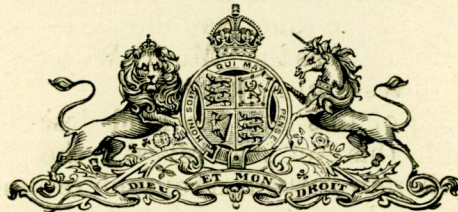

**Manly Water Supply (Panorama Estate
Revesting) Bill.**

EXPLANATORY NOTE.

IN 1922 certain lands, being part of the Panorama Estate, were resumed for the protection of the Manly Water Supply. Prior to resumption the land had been sold in subdivisions, and claims were made by a number of purchasers. Owing to a difference of opinion between the Minister and the claimants as to the value of the lands an action was brought by one of them against the Minister. This action was settled on certain terms which involved a revestment of some of the lands in the original owners.

This Bill is intended to give effect to the terms of settlement arrived at in the said action.

forms part) was resumed for a certain public purpose, namely, the protection of the purity of the water supply at Manly: And whereas it has been found that the said land, described in the Schedule to this Act, is not required for the said purpose, and it is desired to revest the same in the persons who were entitled thereto at the time of the said resumption: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Manly Water Supply (Panorama Estate Revesting) Act, 1924."

Revesting of land described in First Schedule.

2. On the passing of this Act the land described in the First Schedule to this Act shall revest in the persons who were entitled thereto at the time of such resumption as aforesaid and for such estates and interests and with and subject to such rights as were subsisting in respect of the said land at the time of such resumption, and such land shall be subject to all trusts, obligations, estates, interests, contracts, charges, rates, rights-of-way or other easements from which it was freed and discharged by such resumption as if the said land had not been resumed, and shall also be subject to any interests in or equities binding on the compensation moneys created since the said resumption.

Dedication of roads.

3. The lands comprised within the Second Schedule to this Act which are shown as public roads on a plan deposited in the office of the Registrar-General and numbered twelve thousand three hundred and fifteen are hereby dedicated as public roads.

Saving of rights under a certain agreement.

4. Nothing in this Act shall affect the rights of the Minister for Public Works or His Majesty or the Government of the State of New South Wales under a certain agreement bearing date the thirty-first day of March, one thousand nine hundred and twenty-four, made between Albert Edwin Dalwood of the first part Ernest Francis Hartley Brown of the second part the Minister for Public Works of the third part and His Most Gracious Majesty King George V of the fourth part.
