Act No. 71, 1924.

An Act to provide for the carrying into effect of a certain arrangement between the Minister for Public Works, the Municipal Council of Sydney, and David Jones, Limited, relating to the straightening of part of the course of Market-street in the City of Sydney; to vest in David Jones, Limited, certain parcels of land free from any right of highway; to vest in the Municipal Council of Sydney for the purpose of highway, and to form part of Castlereagh-street, Market-street, and Elizabeth-street in the City of Sydney certain lands now vested in the Minister for Public Works and David Jones, Limited, respectively; and for purposes connected therewith. [Assented to, 20th December, 1924.]

Preamble.

WHEREAS the Municipal Council of Sydney is desirous of improving the alignment of parts of Castlereagh-street, Market-street, and Elizabeth-street in the City of Sydney: And whereas certain land at the intersection of Market-street and Elizabeth-street aforesaid is vested in the Minister for Public Works on behalf of His Majesty, but for a considerable time has been used as part of the said streets although no formal dedication has been proclaimed: And whereas it has been arranged between the Minister for Public Works, the Municipal Council of Sydney, and David Jones, Limited, that certain part of the land now vested in David Jones, Limited, should be vested in the said council and become part of Market-street and of Market and Castlereagh streets, and that part of the land so vested in the Minister for Public Works should be vested in David Jones, Limited, and another parcel thereof dedicated as part of Market-street and of Elizabeth-street, and further, that part of the footway of Market-street should be vested in David Jones, Limited, free from any right of highway: And whereas it is desirable to carry the said arrangement into effect: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:—

Short title.

1. This Act may be cited as the "Market-street

(Straightening) Act, 1924."

Divesting and dedication.

street.

2. The lands described in the First Schedule to this Act are hereby divested from David Jones, Limited, the registered proprietors thereof and vested in the Municipal Council of Sydney for an estate in fee simple, and are hereby declared to be dedicated as highway and as additions to Castlereagh-street and Market-street respectively.

3. The land described in the Second Schedule to this Market-street Act is hereby dedicated as highway, to be part of Market-street and Elizabeth-street in the City of Sydney, and shall be under the care, control, and management

of the Municipal Council thereof.

The lands described in the Third Schedule to this Vesting Act are hereby vested in David Jones, Limited, for an parcels in estate in fee simple subject to such reservations and David Jones, conditions as are contained in the Crown grants (if any) Limited. by which the lands were originally granted by the Crown, freed and discharged from any right of highway affecting the same.





Market-street (Straightening) Bill.

EXPLANATORY NOTE.

The Municipal Council of Sydney, being desirous of improving the alignment of parts of Castlereagh-street, Market-street, and Elizabeth-street, has, with the concurrence of the Minister for Public Works, agreed with David Jones, Limited, the owners of the block of land bounded on three sides by those streets, to effect an exchange of certain portions of the said streets for certain areas of land owned by the Company.

A certain area of land at present used as part of Market and Elizabeth streets is still vested in the Minister for Public Works, having been resumed many years ago for the purposes of a public library and was formerly part of the area above referred to now owned by David Jones, Limited. This small area was some years ago thrown into the street by the Minister's permission, but was never formally dedicated.

This Bill is designed to carry out the agreement by-

- 1. Transferring from David Jones, Limited, to the Municipal Council of Sydney two areas of land, one at the corner of Castlereagh and Market streets containing 132 square feet, and one in Market-street containing 167 square feet.
- 2. Transferring from the Municipal Council of Sydney to David Jones, Limited, an area of land in Market-street containing 35 square feet.
- 3. Transferring from the Minister for Public Works to David Jones, Limited, an area of land at corner of Elizabeth and Market streets containing 250 square feet.
- 4. Dedicating an area of 510 square feet as part of Market and Elizabeth streets.

Preamble?

THEREAS the Municipal Council of Sydney is desirous of improving the alignment of parts of Castlereagh-street, Market-street, and Elizabeth-street in the City of Sydney: And whereas certain land at the intersection of Market-street and Elizabeth-street aforesaid is vested in the Minister for Public Works on behalf of His Majesty, but for a considerable time has been used as part of the said streets although no formal dedication has been proclaimed: And whereas it has been arranged between the Minister for Public Works, 10 the Municipal Council of Sydney, and David Jones, Limited, that certain part of the land now vested in David Jones, Limited, should be vested in the said council and become part of Market-street and of Market and Castlereagh streets, and that part of the land so 15 vested in the Minister for Public Works should be vested in David Jones, Limited, and another parcel thereof dedicated as part of Market-street and of Elizabeth-street, and further, that part of the footway of Market-street should be vested in David Jones, Limited, 20 free from any right of highway: And whereas it is desirable to carry the said arrangement into effect: Be it therefore enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New 25 South Wales in Parliament assembled, and by the authority of the same, as follows:-
