BE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows :---

# Transfer of Records Bill, 1923.

## EXPLANATORY NOTE.

THE object of the Bill is as follows :---

(1) To provide for the transfer to the office of the Registrar-General of certain records now in the Supreme Court, and which were lodged or deposited there in pursuance of the Acts mentioned in the First and Second Schedules to the Bill. See Clause 2.

The records dealt with in the Bill consist in the main of bills of sale lodged under the Bills of Sale Act, 1898, affidavits, affirmations, and notices under the Newspapers Act, 1898, and the Printing Act, 1899, and certain memorials, regulations and other documents under the various Acts quoted in the Schedule.

- (2) To confer upon the Prothonotary and the Registrar-General a limited authority to destroy certain bills of sale and documents relating thereto, subject to the safeguards contained in the Bill. See Clauses 3-5.
- (3) To provide that in future records which heretofore were lodged in the Supreme Court in pursuance of the Acts mentioned in the Schedules shall be deposited with the Registrar-General. See Clause 6, which makes necessary verbal amendments in the public Acts affected.

Since certain consequential amendments of the Newspapers Act, 1898, are contained in the Bill, the present opportunity has been taken of introducing an amendment of that Act for the purpose of remedying a slight error in the consolidation. See Clause 6 (2) (c), (f), (g).

# Transfer of Records Bill, 1923.

## EXPLANATORY NOTE.

THE object of the Bill is as follows :----

(1) To provide for the transfer to the office of the Registrar-General of certain records now in the Supreme Court, and which were lodged or deposited there in pursuance of the Acts mentioned in the First and Second Schedules to the Bill. See Clause 2.

The records dealt with in the Bill consist in the main of bills of sale lodged under the Bills of Sale Act, 1898, affidavits, affirmations, and notices under the Newspapers Act, 1898, and the Printing Act, 1899, and certain memorials, regulations and other documents under the various Acts quoted in the Schedule.

- (2) To confer upon the Prothonotary and the Registrar-General a limited authority to destroy certain bills of sale and documents relating thereto, subject to the safeguards contained in the Bill. See Clauses 3-5.
- (3) To provide that in future records which heretofore were lodged in the Supreme Court in pursuance of the Acts mentioned in the Schedules shall be deposited with the Registrar-General. See Clause 6, which makes necessary verbal amendments in the public Acts affected.

Since certain consequential amendments of the Newspapers Act, 1898, are contained in the Bill, the present opportunity has been taken of introducing an amendment of that Act for the purpose of remedying a slight error in the consolidation. See Clause 6 (2) (c), (f), (g).
