Act No. 36, 1924.

An Act to carry into effect the exchange of certain land between the Municipal Council of Sydney and the University of Sydney; to provide a new road; to validate a transfer and subgrant to Saint Paul's College Trustees of certain college lands, portion of land formerly granted to the University of Sydney; to authorise a subgrant to the Women's College; to settle and declare the trusts upon which the land granted to the University of Sydney by the Crown grant dated the eighteenth day of January, one thousand eight hundred and fifty-five, now remaining vested in the University, shall be held; to amend the Victoria and Rushcutter's Bay Parks Act, 1910, and certain other Acts; and for purposes connected therewith. [Assented to. 12th December, 1924.7

DE it enacted by the King's Most Excellent Majesty, by and with the advice and consent of the Legislative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:-

1. This Act may be cited as the "University and College Lands and Victoria Park Act, 1924."

Vesting of land described in in Municipal Council of Sydney.

Short title.

2. The land described in Schedule One, forming portion of land granted to the University of Sydney, Schedule One shall be and the same is hereby vested in the Municipal Council of Sydney for an estate in fee-simple upon the same trusts and with the same powers and subject to the same limitations as if the said land described in Schedule One had formed part of the land described in Schedule One to the Victoria and Rushcutter's Bay Parks Act, 1910, subject as to the land described in Schedule Four to the rights conferred upon the University by section five of this Act.

Vesting of land described in Schedule Two in University.

3. The lands described in Schedule Two, forming part of Victoria Park vested in the Municipal Council of Sydney by the Victoria and Rushcutter's Bay Parks Act, 1910, shall be and the same are hereby vested in the University of Sydney, their successors and assigns for an estate in fee-simple to be held upon the trusts set out in section nine of this Act, subject as to the lands described in Schedule Five to the rights conferred on the Municipal Council of Sydney by section six of this Act.

New road.

4. The lands described in Schedule Three, forming part of Victoria Park aforesaid, and also part of lands granted to the University of Sydney, are hereby declared to be and shall henceforth be a public road, and shall be and the same are hereby vested in the Municipal Council of Sydney as such public road.

Private way over main drive.

5. The University of Sydney shall on such occasions as the Senate of the said University shall declare to be public occasions within the University have full and free right and liberty for its officers, tenants, servants, visitors, and licensees in common with all other persons having the like right on foot, or on horseback, or in motors or other vehicles to pass and repass over the lands described

described in Schedule Four which form part of the lands described in Schedule One and comprise the present main drive to the University for the purpose of access to and egress from the said University and the said lands shall be maintained as a private road by the said

Municipal Council of Sydney accordingly.

6. The Municipal Council of Sydney shall have the Rights of free right of using for the purpose of sewerage and drainage over drainage the lands described in Schedule Five which form part of the lands described in Schedule Two with the right to make and forever hereafter to repair and maintain all such sewers and drains therein as may be reasonable and proper, making good nevertheless at their own expense all damage and disturbance which may be caused to the surface of the said land.

7. (1) A certain indenture of subgrant dated the validation of twenty-ninth day of October, one thousand nine hundred transfer and and twenty-four, and made between the University of Saint Paul's Sydney of the first part the Honorable Sir William Portus College trustees. Cullen, the Honorable Mr. Justice Philip Whistler Street, Alfrey Becher Stewart White, Esquire, Francis Alfred Allison Russell, Esquire, and the Reverend Arthur Henry Garnsey, as trustees for Saint Paul's College of the second part and the Warden and Fellows of Saint Paul's College of the third part, and a certain memorandum of transfer of even date and collateral thereto whereby the land comprised in land grant dated the first day of October, one thousand nine hundred and one, registered volume one thousand three hundred and seventy-five, folio sixty, forming part of the land described in Schedule Six was expressed to be transfered to the said trustees for Saint Paul's College, are hereby validated and shall operate and take effect as if the lands thereby subgranted and transferred being the lands described in Schedule Six including the land comprised in the said land grant of the first day of October, one thousand nine hundred and one, had wholly formed part of the lands granted to the University of Sydney by the said Crown grant of the eighteenth day of January, one thousand eight hundred and fifty-five and subject to the trusts, conditions, and provisos thereof, and as if the said lands formed

formed one of four several portions of the said land consisting each of not less than eighteen acres directed by the said grant to be selected by the Senate of the said University for the purposes in the said Crown grant declared.

(2) In respect of the lands described in Schedule Seven, being land adjoining the lands comprised in Schedule Six and formerly enclosed as lands of Saint Paul's College whereon the Senate of the said University is presently erecting a building intended for use as a Physics Laboratory, the Senate shall not at any time carry the said building or any building on the said land to a greater height than that of the said building now being erected without the consent of the Warden and Fellows of the said college.

Women's College land.

8. Any land including the land whereon the Women's College building is now erected and not being less than two acres and being part of the land granted to the University of Sydney by the Crown grant dated the eighteenth day of January, one thousand eight hundred and fifty-five, which may from time to time hereafter by resolution of the Senate of the University be set apart for the council of the Women's College, being the college incorporated by the Act passed in the fifty-third year of the reign of Her late Majesty Queen Victoria number ten to establish and endow a college for women within the University of Sydney, since repealed and consolidated in the Statute number seventy-one of one thousand nine hundred and two as a site for buildings and recreation grounds for the college, shall be deemed and be taken to be a part or portion of the said grant formerly selected by the Senate of the said University in accordance with the provisions of the said Crown grant for the religious society denominated the Weslevan Methodists but which said selection lapsed and the said University is hereby empowered to make and execute a subgrant of such land or lands being part or parts of the land granted to it by the Crown grant as it may set apart as aforesaid upon trust for the said council of the Women's College in the same manner and with the said

said effect in all respects as if such land so set apart as aforesaid were part of said lapsed portion and as if the Governor with the advice of the Executive Council and after such lapse had nominated the said Women's College as a college in trust for which such land or lands so set apart as aforesaid were to be subgranted.

9. Subject to the provisions of this Act and to Substituted section eighteen of the Wesley College Incorporation trusts of land Act, 1910, and except so far as any of the lands described University. in the said grant of the eighteenth day of January, one thousand eight hundred and fifty-five, are included in the lands described in Schedule One, Schedule Three, and Schedule Six or have heretofore been subgranted by the University of Sydney in pursuance of the said grant to trustees for the Principal and Councillors of Saint Andrew's College or to trustees for the Rector and Fellows of Saint John's College or have been vested in Prince Alfred Hospital under and by virtue of the Prince Alfred Hospital Act, 1902, the whole of the lands described in the said grant are hereby freed and discharged from any trusts in favour of any college under the said grant and shall be and the same are hereby vested in the University of Sydney and their successors for an estate in fee-simple upon trust for the erection thereon of buildings for the said University and for the formation of a park and gardens in connection therewith or for such other purposes in connection with the University of Sydney as the Senate of the said University shall deem fit.

The University of Sydney shall on such occasions as the Senate of the said University shall declare to be public occasions within the University have full and free right and liberty for its officers, tenants, servants, visitors, and licensees in common with all other persons having the like right on foot, or on horseback, or in motors or other vehicles to pass and repass over the lands described

University and College Lands and Victoria Park Bill.

EXPLANATORY NOTE.


This is a Bill to carry into effect certain arrangements between the Municipal Council of Sydney, who are trustees of the Victoria Park, and the University, relating to an exchange of lands and the provision of a new road from City-road to Parramatta-road. The Bill also deals with an arrangement between the University and Saint Paul's College, which is being carried into effect by a transfer and subgrant from the University to Saint Paul's College trustees. As the area which Saint Paul's College trustees are getting is less than that set out in the grant to the University, and as the transaction affects lands which were not included in the original grant it is deemed desirable that the transaction should be validated.

The second subsection of clause 7 is to carry out part of the arrangement, as Saint Paul's College gave up part of its lands affected by this subsection for a Physics Laboratory on the terms that it was not to be carried to a height beyond that agreed to with the College.

Section 8 of the Bill gives power to the University to make a subgrant of land to the Women's College. At the time the land was granted to the University no provision was made for land for woman's College, and it is now thought desirable that the land upon which that College has been built should be vested in the College or in trustees for it.

Section 9 declares more clearly the trusts upon which the land remaining in the University is to be held.

The land to be vested in the Municipal Council of Sydney is that portion which adjoins Parramattaroad and City-road through which the main drive to the University runs, certain rights being reserved to the University over the main drive, which is to be kept by the Council as a private road for University purposes. The land will, in the hands of the City Council, be subject to the provisions of the Victoria Park Act and be a public park. The part of the land to be vested by the Bill in the University is a part of the Victoria Park to the south-east of the present Medical School and between that school and Newtown-road. Certain rights of drainage are reserved to the City Council along a strip 12 feet wide adjoining the Newtown-road. The land to be vested in the Saint Paul's College trustees is approximately that now fenced in and occupied by Saint Paul's College, although a small part of the land lies outside the present fences. The new road to be laid out by the Council will divide the University lands from the Victoria Park. The land which power is given to grant to the Women's College comprises the land upon which present College buildings stand, and its exact boundaries are still a matter of arrangement between the College and the University.

DE it enacted by the King's Most Excellent Majesty, by and with the advice and according to the state of the lative Council and Legislative Assembly of New South Wales in Parliament assembled, and by the authority of the same, as follows:-

Short title.

1. This Act may be cited as the "University and

College Lands and Victoria Park Act, 1924."

Vesting of described in Council of Sydney.

2. The land described in Schedule One, forming portion of land granted to the University of Sydney, Schedule One shall be and the same is hereby vested in the 10 Municipal Council of Sydney or an est ate in fee-simple upon the same trusts and with the same powers and subject to the same limitations as if the said land described in Schedule One had formed part of the land described in Schedule One to the Victoria and Rush- 15 cutter's Bay Parks Act, 1910, subject as to the land described in Schedule Four to the rights conferred upon the University by section five of this Act.

Vesting of land described in Schedule Two in University.

The lands described in Schedule Two, forming part of Victoria Park vested in the Municipal Council 20 of Sydney by the Victoria and Rushcutter's Bay Parks Act, 1910, shall be and the same are hereby vested in the University of Sydney, their successors and assigns for an estate in fee-simple to be held upon the trusts set out in section nine of this Act, subject as to 25 the lands described in Schedule Five to the rights conferred on the Municipal Council of Sydney by section six of this Act.

New road.

4. The lands described in Schedule Three, forming part of Victoria Park aforesaid, and also part of lands 30 granted to the University of Sydney, are hereby declared to be and shall henceforth be a public road, and shall be and the same are hereby vested in the Municipal Council of Sydney as such public road.

Private way over main drive.

5. The University of Sydney shall on such occasions 35 as the Senate of the said University shall declare to be public occasions within the University have full and free right and liberty for its officers, tenants, servants, visitors, and licensees in common with all other persons having the like right on foot, or on horseback, or in 40 motors or other vehicles to pass and repass over the lands described

Women's College land.

8. Any land including the land whereon the Women's College building is now erected and not being less than two acres and being part of the land granted to the University of Sydney by the Crown grant dated the eighteenth day of January, one 20 thousand eight hundred and fifty-five, which may from time to time hereafter by resolution of the Senate of the University be set apart for the council of the Women's College, being the college incorporated by the Act passed in the fifty-third year of the reign of Her 25 late Majesty Queen Victoria number ten to establish and endow a college for women within the University of Sydney, since repealed and consolidated in the Statute number seventy-one of one thousand nine hundred and two as a site for buildings and recreation 30 grounds for the college, shall be deemed and be taken to be a part or portion of the said grant formerly selected by the Senate of the said University in accordance with the provisions of the said Crown grant for the religious society denominated the Wesleyan Methodists 35 but which said selection lapsed and the said University is hereby empowered to make and execute a subgrant of such land or lands being part or parts of the land granted to it by the Crown grant as it may set apart as aforesaid upon trust for the said council of the 40 Women's College in the same manner and with the said

said effect in all respects as if such land so set apart as aforesaid were part of said lapsed portion and as if the Governor with the advice of the Executive Council and after such lapse had nominated the said Women's College as a college in trust for which such land or lands so set apart as aforesaid were to be subgranted.

9. Subject to the provisions of this Act and to Substituted section eighteen of the Wesley College Incorporation retained by Act, 1910, and except so far as any of the lands described University.

10 in the said grant of the eighteenth day of January, one thousand eight hundred and fifty-five, are included in the lands described in Schedule One, Schedule Three, and Schedule Six or have heretofore been subgranted by the University of Sydney in pursuance of the said

15 grant to trustees for the Principal and Councillors of Saint Andrew's College or to trustees for the Rector and Fellows of Saint John's College or have been vested in Prince Alfred Hospital under and by virtue of the Prince Alfred Hospital Act, 1902, the whole of the lands

20 described in the said grant are hereby freed and discharged from any trusts in favour of any college under the said grant and shall be and the same are hereby vested in the University of Sydney and their successors for an estate in fee-simple upon trust for the erection

25 thereon of buildings for the said University and for the formation of a park and gardens in connection therewith or for such other purposes in connection with the University of Sydney as the Senate of the said University shall deem fit.
